This assignment application fully complies with the Commission's multiple ownership rules as is documented by this exhibit. Section 73.3555(a)(1)(iii) provides that a single entity can own up to 6 commercial stations, not more than 4 of which can be in the same service. The principal of Fort Bend Broadcasting Company has an ownership interest in Radio Station WSRI(FM), Beulah, Michigan, Radio Station WSQR(FM), Bear Lake, Michigan, and WLDR(FM), Traverse City, Michigan, all of which overlap the city grade signal of Radio Station WBNZ(FM), the subject of the proposed transfer to Fort Bend Broadcasting Company.

As is shown on the attached map, there are a total of at least 15 signals in the market defined by the overlapping signals of the facilities in which the principal of Fort Bend Broadcasting Company has an interest. From this map it is clear that the common ownership of WSRI(FM), WSQR(FM), WLDR(FM) and WBNZ(FM) is in full compliance with Section 73.3555 of the Commission's Multiple Ownership Rules which provides that in a radio market with between 15 and 29 (inclusive) commercial radio stations, a party may own, operate, or control up to 6 commercial radio stations, not more than 4 of which are in the same service (AM or FM).

The foregoing statements are true and correct of my own knowledge. My qualifications are a matter of record with the Commission.
