**SECOND AMENDMENT TO
AMENDED AND RESTATED OPERATING AGREEMENT
OF
DAVIS MEDIA, LLC, D/B/A LOCAL VOICE MEDIA A
Virginia Limited Liability Company**

THIS SECOND AMENDMENT TO AMENDED AND RESTATED OPERATING AGREEMENT ("Amendment") is entered into by and among Davis Media, LLC, a Virginia limited liability company (the "Company") and the undersigned.

WHEREAS, the Company and the Consenting Member desire to amend the Amended and Restated Operating Agreement of the Company dated November 14, 201 (the "Operating Agreement") in accordance with Section 7.1 thereof and under the terms and conditions set forth in this Amendment;

NOW, THEREFORE, for and in consideration of good and valuable consideration, the receipt and sufficiency of which the parties hereby acknowledge the parties hereby agree as follows:

1. Except as expressly defined in this Amendment, initially capitalized terms in this Second Amendment shall have the meaning ascribed to such terms in the Operating Agreement.
2. Lack of Authority. The following restrictions shall apply to each Member that elects to have its membership interest deemed to be insulated and non-attributable under applicable FCC rules and policy (an "Insulated Member"):
 - (i) No Insulated Member shall act as an employee of the Company or any of its direct or indirect subsidiaries if the Member's functions, directly or indirectly, relate to the media activities of any broadcast radio or television station owned by the Company or any of its direct or indirect subsidiaries;
 - (ii) No Insulated Member shall act or serve as an independent contractor or agent for the Company or any of its direct or indirect subsidiaries with respect to the media activities of any broadcast radio or television station owned by the Company or any of its direct or indirect subsidiaries;
 - (iii) No Insulated Member shall communicate with the members, officers or management of the Company or any of its direct or indirect subsidiaries that are involved in the media activities of any broadcast radio or television station owned by the Company or any of its direct or indirect subsidiaries regarding the day-to-day operation of such stations;
 - (iv) No Insulated Member shall perform any services to the Company or any of its direct or indirect subsidiaries relating to the media activities of any broadcast radio or television station owned by the Company or any of its direct or indirect subsidiaries;

(v) No Insulated Member shall in any other way become actively involved in management or operation of any broadcast radio owned by the Company or any of its direct or indirect subsidiaries.

(vi) the Insulated Members empower the Managing Member to veto any admission of additional Members admitted by vote of the Members.

3. Except as specifically amended by this Second Amendment, the Operating Agreement, as amended by the First Amendment to Operating Agreement, remains effective in accordance with the terms.


