TECHNICAL STATEMENT

1. This Technical Statement and attached exhibits were prepared on behalf of Partnership Radio, LLC (“Partnership Radio”), the licensee of FM station WUBU, Channel 292A, South Bend, Indiana. Partnership Radio also has attributable ownership interest in FM stations WTRC-FM, Channel 237A, Niles, Michigan and WBYT, Channel 264B, Elkhart, Indiana.¹ Partnership Radio has proposed a relocation, change of operating power, and use of a directional antenna for WUBU; therefore, a review of the provisions of multiple ownership rules in §73.555 of the Commission’s rules is warranted. All three of these stations are licensed to the South Bend, Indiana BIA rated market. Therefore, this review will verify that WUBU, WTRC-FM, and WBYT are in compliance in a rated market.

2. Attached as Exhibit B is a listing of the stations in the South Bend, Indiana Market (Market Rank 183). The number of stations depicted falls in the fourteen or fewer station tier of §73.3555(a)(1)(iii) of the Commission's rules. At this level, common ownership or control of up to six stations, with no more than four in the same service in the market, is permissible.

1) Either Partnership Radio, LLC or its members also have an attributable ownership in the following stations: WBYR, Channel 255B, Woodburn, Indiana; WFWI, Channel 222A, Fort Wayne, Indiana; WAOR, Channel 274A, Ligonier, Indiana; WMEE, Channel 247B, Fort Wayne, Indiana; and WOJK-FM, channel 286B1, Hometown, Indiana and AM stations WKJG, 1380 kHz, Fort Wayne, Indiana; WOWO, 1190 kHz, Fort Wayne, Indiana; and WTRC, 1340 kHz, Elkhart, Indiana. As noted on Exhibit A, the city grade contour of the proposed WUBU overlaps with the city grade contour of only WTRC-FM and WBYT.

3. Based on the compliance shown in the rated market reviewed, the co-ownership of WUBU, WTRC-FM, and WBYT remains in compliance with the Commission's multiple ownership rules, with regard to the stations reviewed.

4. The foregoing technical statement was prepared on behalf of Partnership Radio, LLC, by Graham Brock, Inc., its Technical Consultants. All information contained herein is true and accurate to the best of our belief and knowledge. All data relating to AM and FM facilities was extracted from the CDBS database. All data relating to AM and FM facilities in the relevant BIA/Arbitron market was determined using the BIA Financial Network, Inc. Media Access Pro, Version 4.6. BIA database. We assume no liability for errors or omissions in either database which may be adverse to the information contained herein.

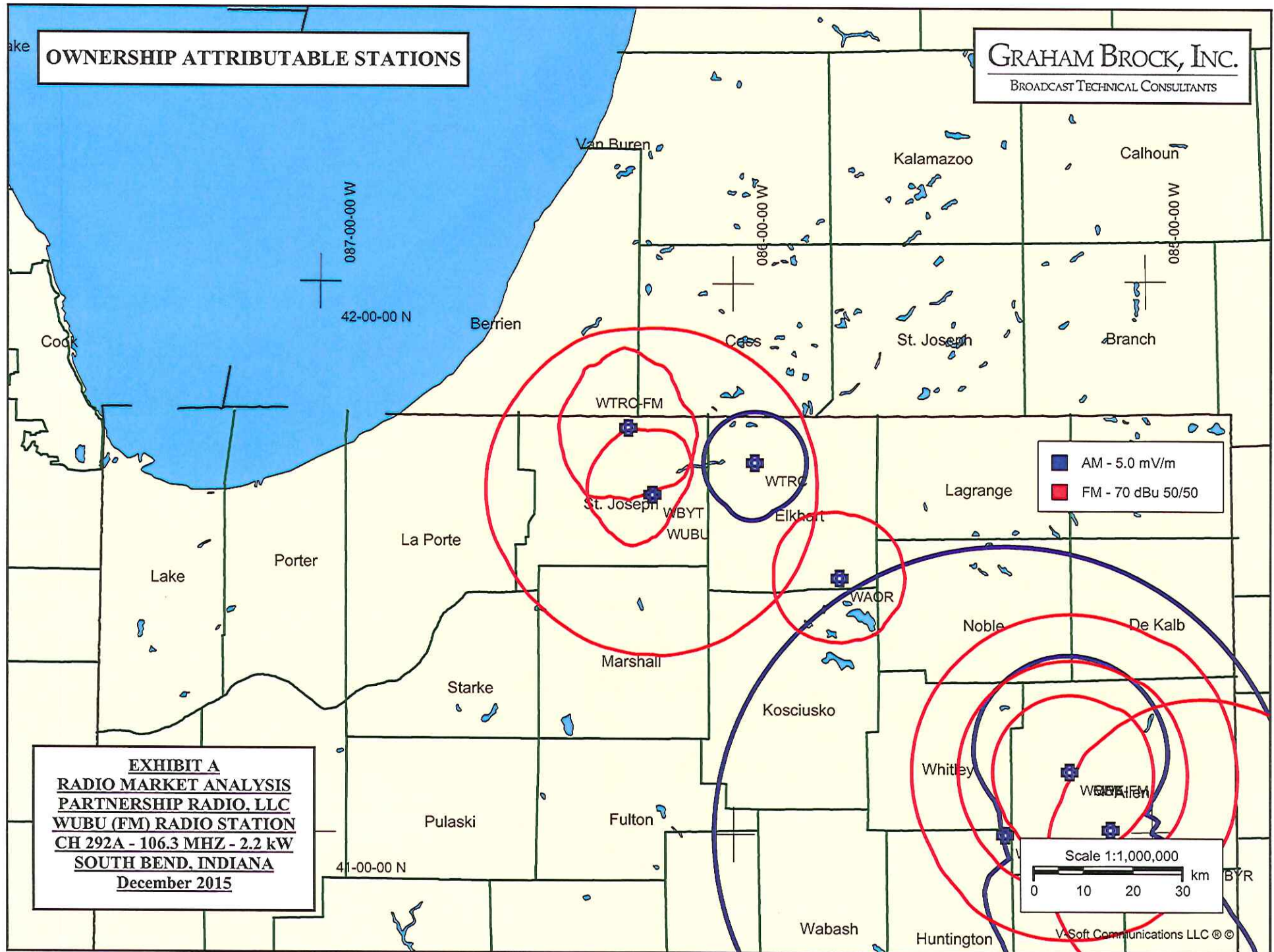



His qualifications are a matter of record before the Federal Communications Commission. He has been active in Broadcast Engineering since 1979.


