Parties to the Application, and Other Media Interests

The instant application seeks Federal Communications Commission (“Commission”) consent to the assignment (“Assignment”) of commercial television station WMBB(TV) (“Station”) from Media General Communications Holdings, LLC (“Assignor”) to Hoak Media of Panama City License, LLC (“Hoak Panama City”).¹

Ownership Structure. Hoak Panama City is a wholly-owned subsidiary of Hoak Media, LLC (“Hoak Media”). The managers of Hoak Media are James M. Hoak and Eric Van den Branden. James M. Hoak is also the chairman of, and holds a 30.3% voting membership interest in, Hoak Media. In addition, James M. Hoak is a 10% shareholder of Hoak & Co., a member with a 0.1% voting membership interest in Hoak Media. The remaining voting members of Hoak Media are as follows: Centennial Hoak Media, Inc. (36.4% voting interest); Columbia Hoak Partners III, Inc. (26.2% voting interest), Columbia Hoak Partners III, LLC (5.1% voting interest), Lanny Martin (1.3% voting interest), Charles A. Anderson (0.3% voting interest), and Richard E. Anderson (0.3% voting interest).² The ownership charts provided in Attachment I report the information requested by Section III, Item 4 for the parties to the application.

Other Media Interests. Except as set forth on Attachment II hereto, no party to this application holds an attributable interest in any radio or television broadcast station, cable television system, or daily newspaper.
