Pursuant to Section 73.1125(d)(1) of the Commission's Rules, Davidson Media Station WWBG Licensee, LLC, Davidson Media Station WTOB Licensee, LLC, and Davidson Media Station WSGH Licensee, LLC, respective licensees of the above-referenced stations, hereby notify the Commission that the main studio for WWBG, WTOB, and WSGH has been relocated to 5252 Ches Lane, Kernersville, NC, 27284. This location satisfies the requirements of Section 73.1125 as follows:


- **WWBG:** The new main studio is located within twenty-five miles of the reference coordinates of the center of Greensboro, NC, WWBG's community of license. 47 C.F.R. § 73.1125(a)(3).
- **WTOB:** The new main studio is located within twenty-five miles of the reference coordinates of the center of Winston-Salem, NC, WTOB's community of license. 47 C.F.R. § 73.1125(a)(3).

- **WSGH:** The new main studio is located within twenty-five miles of the reference coordinates of the center of Lewisville, NC, WSGH's community of license. 47 C.F.R. § 73.1125(a)(3).

The control points for WWBG, WTOB, and WSGH have also been relocated to the above address.
