
1 ORDERED, ADJUDGED AND DECREED that the plaintiff, Radio Station KMJY,  
2 LLC, or its authorized representative(s), is (are) hereby authorized to perform such acts in aid of  
3 the judgments entered in this matter, including without limitation, the prompt filing at the  
4 Federal Communications Commission of application(s) and/or other documents, to (a) assign the  
5 licenses of radio station KQQB-FM, Newport, WA – FCC ID Number 29911 (“Station”) – to  
6 Plaintiff, Radio Station KMJY, LLC; (b) restore the Station’s regular broadcast operations as  
7 soon as possible, including the FCC’s grant of special temporary authority, and; (c) if necessary,  
8 to obtain from the FCC the applicable or appropriate passwords and other identifying  
9 information pertaining to the Station licenses. Defendant Pro-Active Communications Corp. is  
10 also ordered to reimburse all of plaintiff’s costs and its reasonable attorney fees in the preparation  
11 of the applicable application(s) and/or other documents necessary to carry out this Order,  
12 together with plaintiff’s reasonable attorney fees incurred in obtaining this Order.
