At the passing of the primary operator and board president, Reverend William Baker, we at Living Word of Faith Christian Outreach discontinued broadcasting on WTMV, a non-commercial station, on Saturday November 15, 2008 following discussions with the FCC.

I am writing on behalf of the board of directors of Living Word of Faith Christian Outreach, holders of the FCC license for WTMV, Youngsville, Pennsylvania to request a Special Temporary Authority to remain silent for 120 days while staffing issues are resolved.
