Special Operating Restriction

The construction permit for WKTW-LP, BNPL-20131114AEW, contains the following special operating restriction:

“Prior to commencing program tests pursuant to this construction permit, the permittee shall cease operation of, and divest itself of all interest in, station WKTW (FM), Facility ID No. 176558, Longswamp Township, PA. A certification including the date that the station was cancelled or the date the assignment was consummated shall be included as an attachment to the Form 319 application for license to cover this construction permit.”

On December 1, 2017, the applicant, Berks Radio Association (“Berks”) sent a letter to the Commission by United States Postal Service Priority Mail, notifying the Commission of its discontinuance of operation of WKTW (FM) at Longswamp Township, PA. The correspondence also requested the cancellation of license for WKTW (FM). The authorization for WKTW (FM) was included in the correspondence pursuant to §73.1750. This correspondence was delivered to the Commission on December 5, 2017. The correspondence, the mail receipt, and the postal tracking information for this correspondence have been incorporated into this exhibit.

Therefore, by divesting itself of all interest in station WKTW (FM) by discontinuing the operation of WKTW (FM) and returning the license to the Commission for cancellation, Berks now certifies that we have complied with the terms of the special operating restriction. In accordance with §73.860(d), Berks will not commence operation of WKTW-LP until the Commission has cancelled the license for WKTW (FM) and granted the license for WKTW-LP.

DISCONTINUANCE OF OPERATION

Pursuant to the Commission’s Rule §73.1750, Berks Radio Association (“Berks”) is notifying the Commission of its intention to permanently discontinue the operation of station WKTW at Longswamp Township. The licensee requests cancellation of the license for WKTW for the reason stated in this letter. For expediency, per Rule §73.1750, the station license is being surrendered with this letter.

Berks is the permittee of a construction permit for a new Low Power FM Broadcast (LPFM) station, call sign WKTW-LP, at Lenhartsville, PA (BNPL-20131114AEW, Facility ID 196565) and intends to file a license to cover shortly. The construction permit expires on December 9, 2017. At the time of application for construction permit for WKTW-LP, Berks agreed to divest its interest in non-commercial educational Station WKTW (FM) if a construction permit for the LPFM station was granted:

“Berks Radio Association ("Berks") is the licensee of non-commercial educational FM station WKTW at Longswamp Township, PA (Facility ID 176458). Berks hereby agrees that it will divest its interest in WKTW pursuant to §73.860(d) of the Commission’s Rules prior to the Commencement of operation of the proposed LPFM station.”

Thus, there is a restriction for permit BNPL-20131114AEW as follows:

“Prior to commencing program tests pursuant to this construction permit, the permittee shall cease operation of, and divest itself of all interest in, station WKTW (FM), Facility ID No. 176558, Longswamp Township, PA. A certification including the date that the station was cancelled or the date the assignment was consummated shall be included as an attachment to the Form 319 application for license to cover this construction permit.”

Therefore, Berks is complying with its pledge and with Rule 73.860(d) by discontinuing the operation of station WKTW (FM) and divesting itself of WKTW (FM) by forwarding the station license to the Commission for cancellation. Berks requests prompt cancellation so that a license to cover for WKTW-LP may be filed prior to the expiration of the construction permit for WKTW-LP.
