The Freedom Fund is a Non-Stock, Non-Profit corporation chartered in Tennessee with Tax-Exempt status granted by the Internal Revenue Service pursuant to 26 U.S.C. 501(c)(3). The Freedom Fund hereby certifies that it intends to operate station WYTY-LP (FM) in accordance with Section 73.507 of the FCC Rules.

**Educational Mission of The Freedom Fund**

The Freedom Fund (TFF) is a Tennessee non-profit corporation which was formed for charitable, religious, educational and scientific purposes. As noted above, it has been granted tax exempt status pursuant to 26 U.S.C. 501(c)(3) by the Internal Revenue Service.

In practice, TFF's educational mission will involve the following:

- a. Provide regular educational programming designed to teach the Bible and Christianity in a manner which can be utilized by local Christian Churches as well as by the Christian Doctrine educational programs administered by local Christian Churches.
- b. Working with Christian educational and contemplative institutions, including but not limited to Southern Adventist University at Collegedale, Tennessee and other Christian programs for the presentation of quality educational programming.
- c. Provide programming which can be used to train laymen for an active and effectual role in the Christian Church life, such as missions, pastoral and teacher, etc.

**Programming in Furtherance of TFF's educational Mission**

Programming to be aired by TFF over WYTY-LP (FM) will come from a number of sources, including but not limited to, the radio services of Community Public Radio (CPR) and Life Talk Radio (LTR). CPR is headquartered in Athens, Georgia which is a Christian program provider; that is, the teaching of the gospel of Jesus Christ and a Positive walk with Christ through Christian music and commentary. LTR is headquartered in Collegedale, Tennessee and is a Christian program provider; that is, the teaching of the Gospel of Jesus Christ, programs that help Connect People with Christ through music, teaching and preaching.

TFF's programming is commercial-free, and there is no paid programming which is aired on CPR or LTR. Such programming would be broadcast over WYTY-LP (FM) in a commercial-free manner. Programming consists of the following types; (1) rebroadcasts of "Interactive" programs which will involve a host or moderator and a call-in questions from listeners; (2) recorded programs presented by CPR and LTR, there program providers dealing with various topics of the Gospel of Jesus Christ. (categories 1 and 2 occupy approximately 85 percent of the broadcast day); (3) Christian Church services, Devotionals; and (4) news programs.

With respect to the interactive programs that would be carried over WYTY-LP (FM), here are some brief descriptions of examples of such programs which have been offered in recent years by CPR and LTR to local stations; Examples of recorded programs conducted by Christian scholars are:

Dr. Michael Guido "Seeds from the Sower"  
"A Seed From the Sower," is a one-minute daily inspirational spot. "Seeds From the Sower," is a five-minute daily program.

Kay Authur "Precepts from God's word"  
A half-hour daily program with Kay covers relevant, in-depth topics for everyday life.

Ron Hutchcraft "A word with you"  
A 4 1/2 minute daily broadcast, in which Ron Hutchcraft uses humor and the Bible to present practical applications for daily living. Regularly, Ron clearly introduces spiritual seekers to a relationship with Jesus Christ.

Ron Hutchcraft "Realtime"

A 30-minute program with no breaks. Each topic is delivered in a different manner each week with an unpredictable style. Our only template is to deliver God's Word to the lost young people. "Realtime" will have a non-linear approach and give the listener information in bursts rather than long blocks.

Billy Graham "Hour of Decision"

"The Hour of Decision" is the weekly radio ministry of the Billy Graham Evangelistic Association. The first broadcast of "The Hour of Decision" aired November 5, 1950, as a live radio program featuring Billy Graham's message "Revival." Today it broadcasts the Gospel messages presented by Billy and Franklin Graham around the world.

Billy Graham "Decision Minute"

Decision Minute is a 60-second program challenging the believer and unbeliever to the cause of Jesus Christ through short messages from Billy and Franklin Graham. The broadcasts also feature testimonies and short stories of how God is working in people's lives.

Luis Palau "Reaching your world"

It's wonderful to share with you practical, "I can do it!" ways to reach your world with the Gospel message. I pray that this exciting radio program will encourage you to share the Good News with your friends and family every day. So drop the guilt and tune in today! This is your chance to share your faith with the people you love.

Joni Eareckson Tada "Joni and friends"

"Joni and Friends" is a daily, five-minute inspirational program dealing with a wide range of topics, with a biblical perspective. As she tackles issues relating to disability awareness, Joni provides a uniquely personal, biblically inspired insight into some of life's tougher questions. Her contagious joy and unwavering faith have provided hope for thousands who find themselves faced with life's crippling blows.

Family Radio Network "Powerline"

Powerline is an upbeat blend of adult contemporary hits and inspirational messages hosted by Jon Rivers.

Family Radio Network "Country Crossroads"

Country Crossroads features top Country hits with interviews from top country music personalities.

Family Radio Network "Strength for Living"

Strength for Living is contemporary teaching that offers hope for today and encouragement for life with an appealing blend of current and traditional worship songs.

James Dobson "Focus on the Family"

Thus, the TFF radio programming to be presented over WYTY-LP (FM) presents a comprehensive daily effort to educate the public, Christian and non-Christians, about the Christian faith, including the Holy Bible, Jesus Christ and the Christian Church. TFF intends to work with the Christian Churches, Christian programs and organizations to assist their educational efforts with respect to the teaching of the Christian religion and faith. In short, TFF intends to develop WYTY-LP (FM) as a valuable educational resource which will serve the public interest, convenience and necessity.

**BY-LAWS**  
**of**  
**The Freedom Fund**

**Article I**  
**Identification and Location**

- Section 1.01      The Name. The Freedom Fund
- Section 1.02      Registered Office Location. The registered office of the Corporation shall be at 5509 Barrington, Ooltewah, Hamilton County, Tennessee, 37363, until otherwise established by an amendment of the Articles of Incorporation or by the Board of Directors and a record of such change is filed with the Department of State in the manner provided by law.
- Section 1.03      Other Offices. The Corporation may also have offices at such other places within or without the State of Tennessee as the Board of Directors may from time to time appoint or the business of the Corporation may require.

**Article II**  
**Maintenance of Exempt Status as 501 (c)(3) Organization**

The Freedom Fund has been formed to operate exclusively for the sole purpose including, but not limited to the following:

- Section 2.01      The sole purpose for which The Freedom Fund is organized is exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
- Section 2.02      Notwithstanding any other provision of these articles, this organization shall not carry on any activity not permitted to be carried on by an organization exempt from Federal Income tax under section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
- Section 2.03      Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding section of any future federal tax code of the United States Internal Revenue law.
- Section 2.04      The Corporation is a non-profit corporation.
- Section 2.05      The Freedom Fund may from time to time conduct other charitable activities and may also provide assistance to local, national or international missions work after approval of the Board of Directors.

**Article III**  
**Objectives and purpose**

- Section 3.01 To maintain The Freedom Fund according to the Rules set forth by the Internal Revenue Service.
- Section 3.02 To maintain the Federal Communications Commission (FCC) License of WYTY-LP (FM) according to the rules and regulations set forth by the FCC.
- Section 3.03 To maintain WYTY-LP FCC License, required books and records, equipment, programming controlled by The Freedom Fund, with the option for patrons to make contributions for the regular maintenance of the facilities and support items.

Article IV  
Board Members

- Section 4.01 The Board Members of this Fund will include at least three individuals: (1) The chairman/President, (2) the Registered Agent/Treasurer and (3) the Secretary.
- Section 4.02 There will be at least one (1) meeting each year.
- Section 4.03 Special meetings may be called by its officers by notifying all officers. Each meeting request must be communicated by telephone, US Mail or personal notification.
- Section 4.04 Each meeting, be it regular or special, must be preceded by a notice at least seven (7) days prior to that meeting, which may be accomplished via telephone, US Mail, Electronic Mail (e-mail) or personal notification.
- Section 4.05 Robert's Rules of Order will be the Authority for all procedures during meetings conducted by The Freedom Fund.

Article V  
Board Responsibility; Provisions for Regulation of Business and  
Conduct of Affairs of the Corporation

- Section 5.01 The affairs of the Corporation shall be managed by the Board of Directors of the Corporation.
- Section 5.02 This Fund will have the power to indemnify, hold harmless any officer, advisor or any member from any suit, damage, claim judgment and/or liability arising out of, or asserted to rise out of conduct by such persons in his or her capacity as an officer, advisor, or member (except in the case of willful misconduct). This Fund will have the power to purchase or procure insurance for such purpose, if needed.
- Section 5.03 The Fund officers may enter into any contract or execute and/or deliver any instrument in the name of and on behalf of this Fund only after it has been voted on by the officers at a regular or special meeting.
- Section 5.04 All checks, drafts and other orders of payment of money will be signed by the Secretary and the Treasurer/Trustee. All documents will require at least two (2) signatures, one of which will be that of the Secretary and the other may be that of the Treasurer/Trustee.
- Section 5.05 In the absence or incapacitation of one of the officers designated to sign such documents, one signature will be allowed notifying the other officers of the Fund.

Article VI  
Committees

Section 6.01 The officers of the Fund may appoint additional committees, as needed. Each committee will consist of at least one (1) chairperson.

Article VII  
Books and Records

Section 7.01 The Corporation shall keep appropriate, complete and accurate books and records of accounts and will also maintain recorded minutes of all meetings, proceedings, and official activities of the business, or its officers, advisors and committees; and will keep at the Registered Agent's office a record of name and addresses of each officer indicating their authority to vote. All books and records may be inspected by any member upon request with a minimum notice of forty-eight (48) hours, on regular business days, to the Registered Agent.

Article VIII  
Fiscal Year

Section 8.01 The fiscal year for The Freedom Fund will end on June 30 in each year.

Article VIII  
Amendments


Section 9.01 The Board of Directors of this Fund may amend these by-laws to include or omit any provision that it could lawfully include or omit at the time the amendment is made.

Section 9.02 No more than three (3) provisions may take place at one (1) time. Upon written notice of at least thirty (30) days any amendments of the by-laws may be submitted and voted on at a single meeting of the officers of this Fund and will be adopted at such meeting upon receiving a majority vote of the officers of this organization.



**ARTICLES OF AMENDMENT  
TO THE CHARTER OF THE FREEDOM FUND**

Pursuant to the provision of Section 48-201-106 of the Tennessee Business Corporation Act, the undersigned Corporation adopts the following articles to its charter:

1. The name of the Corporation is: **The Freedom Fund.**

2. The text of the amendment adopted is:

BE IT RESOLVED, Amendments to the By-Laws of The Freedom Fund reflected The Freedom Funds main Purpose (along with other amendments made within the document itself). The changes are related to the FCC License of WYTY-LP (FM), The Freedom Funds main concern. The radio station programming, educational purpose and the management of the equipment and offices.

3. The corporation is a non-profit corporation.

4. The amendment was duly adopted on the *17th day of January 2006*, by incorporator, stockholder vote being unnecessary and not required.

5. Additional approval for the amendment as permitted by Section 48-60-301 of the Tennessee Nonprofit Corporation Act was not required.

6. The amendment is effective when amendments of the articles are filed by the Secretary of State.
