**TECHNICAL STATEMENT**

1. This technical statement and attached exhibits were prepared on behalf of Legend Communications of Wyoming, LLC ("Legend"), licensee of radio station KLGT, Channel 225C1, Buffalo, Wyoming. Legend is submitting a minor change application for KLGT to relocate the site 0.23 kilometer from its licensed site. This relocation will change the defined radio market. Legend also has attributable interests in the license of KBBS, 1450 kHz, Buffalo, Wyoming, and is the permittee of KZZS, Channel 252C2, Thermopolis, Wyoming.<sup>1</sup> The 3.16 mV/m contours of KLGT and the proposed KZZS overlap. The 3.16 mV/m contours of the two FM stations also overlap with the 5.0 mV/m contour of KBBS. This results in Legend having attributable interests in two FM facilities and one AM facility in the same radio market. Exhibit #1 is a map depicting the subject stations.

2. A study has, therefore, been conducted to determine if ownership of these facilities complies with §73.3555 of the Commission's rules. The subject stations' contours, therefore, establish the market boundary, hereinafter referred to as the "Radio Market". The study will determine the number of other commercial AM and FM stations that either have transmitter sites within the subject radio market, or have principal community contour overlap with the subject stations.

1) KZZS was ordered to Channel 252C1 at Story, Wyoming, and Legend is submitting an application proposing operation on the new channel at Story. The application site is considered in this Radio Market Analysis.

3. Exhibit #2 is a depiction of the Radio Market with the transmitter sites or city grade contours of seven commercial AM and FM stations, including the subject stations.<sup>2</sup> Exhibit #3 is a tabulation of the stations in the radio market. The number of stations depicted falls in the fourteen or fewer stations tier of §73.3555(a)(1)(iv) of the Commission's rules. At the fourteen or fewer stations level, common ownership or control of up to five stations, with no more than three in the same service, is permissible. Therefore, Legend's interests in two FM stations and one AM station in the same radio market are in compliance with the Commission's rules. Therefore, Legend's proposed minor change application for KZZS is in compliance with §73.3555 of the rules.

2) Although there are additional stations providing service to the Radio Market, they are not considered since the number of stations was ample to demonstrate compliance with the rules based on the number of stations proposed to be commonly owned.

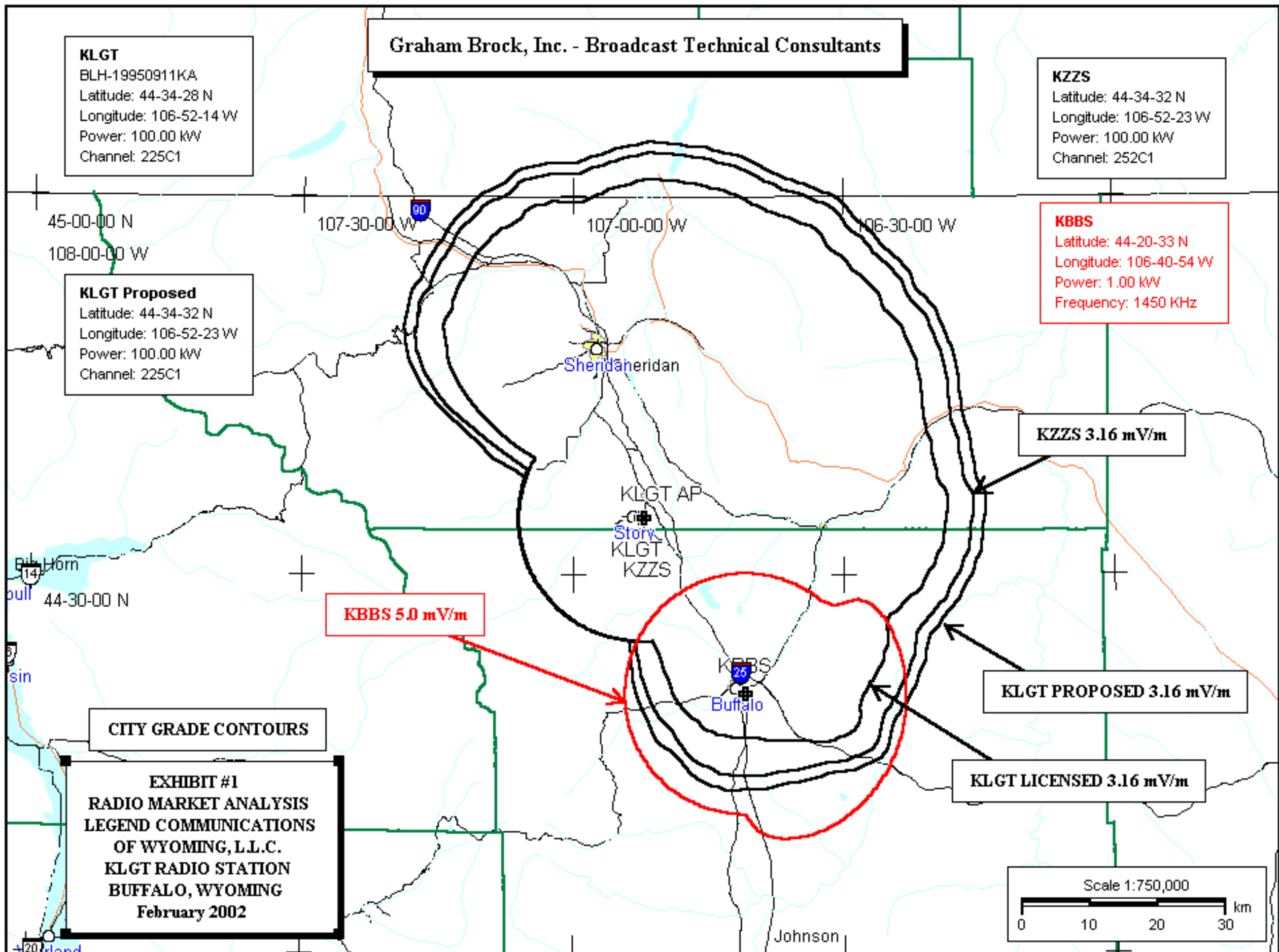
