TECHNICAL STATEMENT

1. This technical statement and attached exhibits were prepared on behalf of Miller Communications, Inc. ("Miller"), licensee of radio stations WWBD, Bamburg, South Carolina; WQKI-FM, Orangeburg, South Carolina; WQKI (AM), St. Matthews, South Carolina; and WGFG, Branchville, South Carolina.¹ Miller has proposed changes to WWBD which have a minor effect on the radio market(s) as defined by the Commission.

2. As demonstrated in Exhibits #1 and #2, there are contour overlap issues which exist between the above noted licensed stations. These contour overlaps comply under the provisions of §73.3555 (a)(1)(iii) for co-ownership of up to five broadcast entities, three of which may be in the same broadcast service. This results in Radio Market #1 consisting of stations WWBD, WQKI-FM, WGFG and WQKI(AM), while Radio Market #2 consists of stations WWBD, WQKI-FM, WGFG (application) and WQKI(AM). The co-ownership of these stations is allowed under §73.3555(a)(2).

3. To simplify compliance with the multiple ownership provisions of §73.3555, we will consider ONLY the proposed WWBD city grade contour as a most conservative market

boundary. In order to determine compliance, this study examines the number of stations providing city grade service to the WWBD proposed city grade contour or who have sites falling within the city grade contour of this subject station. This contour establishes the market boundary, hereinafter referred to as the "Radio Market".

4. Exhibit #3 is a map showing the contributing stations while Exhibit #4 is a tabulation of the stations considered. There are ten stations (excluding the subject stations) in the Radio Market. Therefore, co-ownership of WWBD, WQKI-FM, WGFG, and WQKI (AM) in one market is in compliance with the Commission's multiple ownership rules (73.3555(a)(iv)).

5. The foregoing technical statement was prepared on behalf of Miller Communications, Inc., by Graham Brock, Inc., its Technical Consultants. All information contained herein is true and accurate to the best of our belief and knowledge. All data relating to AM and FM facilities was extracted from the pertinent CDBS database. 
