Attributable Parties

The assignees in the instant transaction are four limited liability companies (“LLCs”): KXXV License Subsidiary, LLC, KFDA/KEYU License Subsidiary, LLC, KSWO License Subsidiary, LLC, and KWES License Subsidiary, LLC. Each licensee LLC is owned by a separate LLC (respectively: KXXV LLC, KFDA/KEYU LLC, KSWO LLC, and KWES LLC). Those LLCs are all, in turn, owned by TV-3, LLC. TV-3 LLC’s owner and sole member is Raycom TV Broadcasting, LLC. The owner and sole member of Raycom TV Broadcasting, LLC is TV Stations Holdings, LLC. Raycom Media, Inc. (“Raycom”) owns 100% of TV Stations Holdings, LLC (77.41% directly, with the remaining interest held indirectly, through Liberty TV Group, LLC, a single-member LLC whose sole member is Raycom).
