

EXHIBIT 1

This application proposes to both relocate and displace analog WRNN-LP channel 57 Nyack, NY. The relocation is 21 miles from Pleasantville, NY to Roslyn, NY, and the displacement is to digital channel 26. Appendix 1 is a list, by channel number from 2 to 51, of the call letters of all TV stations less than 40 miles from Nyack, NY. It is shown that no channel is available for digital in-core displacement.

However, WNXV-LP channel 26, New York, plans to transition to digital channel 43 sometime after June 12, 2009, for which it holds a cp in the same NYC location and with similar coverage to WNXV-LP channel 26. (This transition is necessary because WTBV-DT channel 27 Poughkeepsie, NY prevents WNXV-LD from operating on channel 26 in or near its present location or coverage.)

This situation allows a viable channel 26 digital station to be built in Roslyn NY. A Longley-Rice analysis, using the same program used by the FCC and the 2000 census data, shows that the proposed WRNN-LD channel 26 in Roslyn interferes with no service except WNXV-LP, which agrees to accept such interference (see letter of acceptance as Appendix 2).

This move and displacement is the only alternative found for WRNN-LP channel 57 to enter the core, as a digital station, with economically viable coverage. The proposed coverage is the closest overlap that can be obtained without interfering with WYBY-DT channel 27.

Appendix 3 shows the overlap between the protected contours of the channel 57 license and the proposed channel 26.


