

**SUMMARY OF THE TRANSACTION  
AND OTHER AUTHORIZATIONS**

This exhibit is being filed in connection with a series of transfer of control and license assignment applications either filed on December 20, 2013 or being filed concurrently herewith that seek Federal Communications Commission ("FCC" or "Commission") approval to effectuate the sale of substantially all of the assets of Hoak Media, LLC ("Hoak Media"), the parent of licensees of various television broadcast stations in nine markets.<sup>1</sup> This exhibit provides an overview of these applications, as well as a list of the broadcast stations in which Hoak Media and other parties with an attributable interest in Hoak Media currently hold other authorizations.

**Overview:**

This application ("Application") is filed in connection with a series of related applications seeking FCC consent to (1) the transfer of control from Hoak Media to Gray Television Group, Inc. ("Gray Television") of Hoak Media of Dakota License, LLC, Hoak Media of Nebraska License, LLC,<sup>2</sup> Hoak Media of Louisiana License, LLC, and Hoak Media of Alexandria License, LLC, the holders of licenses for various full power television, satellite television, Class A television and/or television translator stations; (2) the assignment of the license of KHAS-TV, Hastings, Nebraska, from Hoak Media of Nebraska License, LLC to Excalibur Hastings, LLC ("Excalibur"); and (3) the transfer of control of the FCC licenses of Hoak Media of Panama City License, LLC and Hoak Media of Colorado License, LLC from Hoak Media to Nexstar Broadcasting, Inc. ("Nexstar"). The Purchase Agreements for the transaction that is the subject of this Application are attached as Exhibits 7 and 15.

**Other Authorizations:**

Hoak Media is the parent company of **Hoak Media of Alexandria License, LLC** ("Hoak Alexandria"). On December 20, 2013, Hoak Media filed an application (FCC File No. BTCCDT-20131220GPK) for FCC approval to transfer control of Hoak Alexandria to Gray Television. Hoak Alexandria holds a Commission authorization for the following commercial television station:

Hoak Nebraska holds Commission authorizations for the following full power commercial television stations, Class A television station, and television translator stations:

On December 20, 2013, Hoak Nebraska also filed an application (FCC File No. BALCDT-20131220GPS) for FCC approval of the assignment of the license of KHAS-TV to Excalibur. The transfer of control of Hoak Nebraska to Gray Television referenced above is contingent on the prior approval and consummation of the KHAS-TV license assignment to Excalibur.

Hoak Media is the parent company of **Hoak Media of Colorado License, LLC** (“Hoak Colorado”). Hoak Media is concurrently filing an application for the transfer of control of Hoak Colorado from Hoak Media to Nexstar. Hoak Colorado holds Commission authorizations for the following commercial television stations, class A television station, and television translator stations:
