**SUSQUEHANNA RADIO CORP.**  
**WRWM (FM) RADIO STATION**  
**CH 230B1 - 93.9 MHZ - 6.9 KW**  
**LAWRENCE, INDIANA**

**TECHNICAL STATEMENT**

This Technical Statement was prepared on behalf of Susquehanna Radio Corp. ("SRC"), licensee of radio station WRWM, Channel 230A, Fishers, Indiana. SRC holds a permit authorizing a upgrade for WRWM with a change in community of license from Fishers, Indiana to Lawrence, Indiana at the existing WRWM site (BPH-20070820ABO). No other changes were proposed for WRWM. SRC herein submits a license application to cover the outstanding permit. A calculation of the transmitter power output of the WRWM transmitter is attached as Exhibit A. WRWM is ready to commence Program Tests with the authorized facility, but has not done so.<sup>1</sup>

There are four operating conditions/restrictions on the WRWM permit. The first condition on the WRWM permit states that program tests pursuant to this instant permit will not commence until WLCL (formerly WQKC-FM) commences program tests and a license for WRWM will not be granted until a license for WLCL is granted. WLCL was granted a license to cover its outstanding permit on January 25, 2008 (BLH-200712518ABI). As such, this condition has been satisfied.

1) The change of community of license for WRWM from Fishers, Indiana to Lawrence, Indiana would remove the sole service from Fishers, Indiana. While not specifically noted as a condition on the WRWM permit, FM station WFMS has a permit to change community of license from Indianapolis, Indiana to Fishers, Indiana as a replacement service (BPH-20070820ABN). An application to license WFMS at Fishers is being submitted simultaneously with this instant application.



The second condition on the WRWM permit states that program tests pursuant to this instant permit will not commence until WPFR-FM commences program tests and a license for WRWM will not be granted until a license for WPFR-FM is granted. In MB Docket 05-67, WPFR-FM was ordered to change from Channel 230A to Channel 229A at its existing transmitter site. WPFR-FM has a valid construction permit to change to Channel 229A (BPH-20071107ACL), but to date has not implemented the change nor does SRC believe that the change is imminent. As such, SRC requests a waiver of Condition #2 on the WRWM permit. A waiver of this condition will allow WRWM to commence operation on Channel 230B1 to provide first service to Lawrence, Indiana. See the statement by Mark Lipp, Esquire, regarding this matter which is attached elsewhere in this application.

The third condition states that SRC will reduce the power of WRWM, or cease operation in coordination with other users of the tower, to protect persons having access to the site from radio frequency electromagnetic fields in excess of FCC guidelines. SRC will comply with this condition.

The last condition states that the grant of this permit is conditioned on the final outcome of MB Docket 05-67 and that the final outcome of proceeding may require SRC to change frequency, class or site location. Accordingly, any construction undertaken pursuant to this permit is at the permittee's sole risk. SRC acknowledges this condition. Based on the foregoing, it is believed that WRWM has been constructed in compliance with the Commission's rules and is ready to operate, with the exception of Condition #4, as addressed above.
