

EXCHANGE AGREEMENT

This AGREEMENT is entered into this 30th day of April, 2010, by and between CALVARY CHAPEL OF TWIN FALLS, INC. (hereinafter called CCTF) and PACIFIC CASCADE COMMUNICATIONS CORPORATION (hereinafter PCC) of Redding, California.

RECITALS

A. CCTF is the exclusive owner of FM Radio Broadcast Translator K260AK, the 88.3 community of license for which is Klamath Falls, Oregon, FCC facility ID No. 1268216, located on Stukel Mountain, Klamath County, Oregon, including all governmental licenses, permits and authorizations issued by the Federal Communications Commission ("Commission"), the translator equipment for its use at the transmitter site, and the exclusive right to own and operation the translator (hereinafter called "Klamath Falls Translator").

B. PCC is the exclusive owner of FM Radio Broadcast Translator K271AR, the community of license for which is Coos Bay, Oregon, FCC facility ID No. 143727, located on Blossom Hill, Coos County, Oregon, including all governmental licenses, permits and authorizations issued by the Federal Communications Commission ("Commission"), the translator equipment for its use at the transmitter site, and the exclusive right to own and operation the translator (hereinafter called "Coos Bay Translator").

C. CCTF desires to assign and transfer to PCC all of the right, title and interest of CCTF in the Klamath Falls Translator, and PCC desires to assign and transfer to CCTF all of the right, title and interest of PCC in the Coos Bay Translator. In addition to the FCC license for its operation, the assignment and transfer of each translator shall include ownership of the translator equipment set forth in Exhibits A and B, presently in use at the transmitter site, and in addition, all right and interest in and to contracts, leases, and permits pertaining to and necessary for the use of each of the respective translator transmitter sites.

D. CCTF and PCC each agree that the Klamath Fall Translator and the Coos Bay Translator are of equal value, and it is the desire, intention and agreement of CCTF and PCC to assign, transfer and trade the translators of each party to the other as an exchange of equal value, free of any consideration other than the assignment and transfer of each translator. Both parties agree that its translator and the rights thereto shall be free and clear of all liabilities, liens, or encumbrances of any kind.

E. The translators cannot be assigned and transferred without the prior consent of the Commission. The parties agree that within thirty (30) days of execution of this Agreement, each of the parties shall prepare and file with the Commission an application for Consent to Assignment for its respective translator. Unless the Commission's Consent to Assignment is granted and the assignment and transfer of ownership is completed for both translators within 180 days from the date of this agreement, this agreement will expire. Time is of the essence of this Agreement.

F. Each of the parties shall bear its own expenses incurred in connection with the assignment and transfer.

G. Any dispute between the parties arising out of this Agreement shall be decided by Arbitration and not by court action.

IN WITNESS WHEREOF, the parties have caused this Agreement to be executed on its behalf, to be effective as of the date first above written, with the intent to be legally bound.
