MULTIPLE OWNERSHIP

Foxfur Communications, LLC ("Foxfur") is commonly-owned with Cram Communications, LLC, licensee of WSIV(AM), E. Syracuse, NY, WAMF(AM), Fulton, NY, and permittee of WVOA(AM), DeWitt, NY. It is also commonly-owned with Renard Communications Corp., licensee of WVOA-FM, Mexico, NY and WOLF Radio, Inc., licensee of WOLF(AM) Syracuse, NY and WOLF-FM, Oswego, NY all of which are located within the Syracuse, NY market as designated by Arbitron. The Syracuse market consists of three counties: Onondaga, Oswego and Madison. Stations within the market are as follows:

Based on the Commission's multiple ownership rules in Section 73.3555(a)(ii), in a market with between 30 and 44 (inclusive) stations, a party may own up to 7 commercial radio stations, not more than four of which are in the same service. The proposal for the assignment of WWDG(FM), DeRuyter, NY, to Foxfur would be in compliance as Foxfur, combined with its commonly-owned affiliates, Cram Communications, LLC, WOLF Radio, Inc., and Renard Communications Corp. would own seven stations (4 AM and 3 FM) in the Syracuse market.
