

This application is part of a series of five applications being filed simultaneously seeking consent to the assignment of the licenses of the following five Wichita, Kansas area radio stations to subsidiaries of SummitMedia, LLC.

No parties holding interests in the proposed assignees currently hold any other interests in the markets of these stations.

Each of the stations is listed as “home” to the Wichita, Kansas metro radio market by BIA. KFDI-FM, KFTI(AM), KFXJ(FM), and KICT-FM are each licensed to a community located within the geographic boundaries of that market. KYQQ(FM) is licensed to a community located outside the boundaries of the BIA-defined metro radio market. As a result, this application demonstrates compliance with the ownership rules under both the metro market methodology and the interim contour overlap methodology.

Metro Market Methodology: As shown in the BIA report attached as Exhibit A, the Wichita metro radio market includes a total of 33 stations. In such a market, Section 73.3555(a)(1)(ii) of the FCC rules allows a party to hold attributable interests in up to seven total stations, including four in the same service. The proposed acquisition of four FM stations and one AM station in the market therefore complies with the Commission’s multiple ownership rules under the metro market methodology.

Interim Contour Overlap Methodology: As shown in the map attached at Exhibit B, the contours of all stations that are part of this transaction in the Wichita area overlap, creating a single market for contour overlap analysis. As shown in Exhibit C, at least 42 stations have principal community contours that intersect with or define that market and have transmitter sites within 92 km of that market. In such a market, Section 73.3555(a)(1)(ii) of the FCC rules allows a party to hold attributable interests in up to seven total stations, including four in the same service. The proposed acquisition of four FM stations and one AM station in the market therefore complies with the Commission’s multiple ownership rules under the interim contour overlap methodology.


Principal Community Contours of Stations Included in this Application
