Denver, Colorado
Multiple Ownership - Satellite Exemption Request, Duopoly Showing
and Radio-Television Cross-Ownership Showing

This application seeks FCC consent to the transfer of control of Community Television of Colorado License, LLC (“Community Television Colorado”), the licensee of television stations KDVR(TV), Denver Colorado, and KFCT(TV), Fort Collins, Colorado, from the members of Local TV Holdings, LLC (“Local TV”) to Tribune Broadcasting Company II, LLC, a wholly-owned subsidiary of Tribune Company (together, “Tribune”). KFCT(TV) currently is operated as a full power “satellite” of KDVR(TV) pursuant to Note 5 of Section 73.3555 of the Commission’s Rules. Tribune, through its subsidiary KWGN LLC, owns KWGN-TV, Denver, Colorado. This exhibit respectfully requests continued authorization to operate KFCT(TV) as a satellite of KDVR(TV). This exhibit also demonstrates that common ownership of KDVR(TV) (together with satellite station KFCT(TV)) and KWGN-TV would comply with the Section 73.3555(b) of the Rules, the Local Television Multiple Ownership Rule (the “Duopoly Rule”).

Oaktree Capital Group Holdings GP, LLC (“Oaktree”) has an attributable interest in Tribune through certain affiliated funds.¹ It also has an attributable interest in Townsquare Media LLC (“Townsquare”), which in turn holds attributable interests in four Denver-area radio stations: KMAX-FM, Wellington, KTRR(FM), Loveland, and KUAD-FM, Windsor, all

Colorado, and KOWB, Laramie, Wyoming.² This exhibit also demonstrates that Oaktree's attributable interests in Townsquare's radio stations and in the above-referenced television stations would comply with the Section 73.3555(c) of the Rules, the "Radio-TV Cross Ownership Rule."

1. Request for Continued Satellite Authority for KFCT(TV).

KFCT(TV) has operated as a satellite of KDVR(TV) continuously since commencing operations in 1995, and the Commission repeatedly has reauthorized KFCT(TV)'s satellite status, most recently in 2008.³ The material facts supporting treatment of KFCT(TV) as a satellite have not changed since that time. Accordingly, Tribune respectfully requests continued authority pursuant to Note 5 to Section 73.3555 of the Rules to operate KFCT(TV) as a satellite of KDVR(TV).

An applicant for satellite status is presumptively entitled to a satellite exemption if three criteria are satisfied: (1) there is no City Grade contour overlap between the parent station and the proposed satellite station; (2) the proposed satellite station would provide service to an underserved area; and (3) no alternative operator is ready and able to construct or to purchase and operate the satellite station as a full-service station.⁴ KFCT(TV) qualifies for satellite status

under this test. Thus, it is not necessary for the Commission to consider the other factors that it may take into account under an *ad hoc* analysis in cases where the presumptive test is not satisfied. (Tribune respectfully requests that the Commission process this request under the *ad hoc* analysis if the Commission determines that the presumptive test has not been satisfied here.)

No City Grade Overlap. The stations no longer have City Grade contours, as those contours are determined by analog service patterns. Prior to the digital transition, however, when the stations had analog broadcasts, the Commission determined that the stations' City Grade contours did not overlap.⁵ Neither KFCT(TV) nor KDVR(TV) modified its analog facilities following that determination.

Service to Underserved Areas. KFCT(TV) continues to serve an underserved area. An applicant may demonstrate that a proposed satellite station serves an underserved area by demonstrating either (a) that there are two or fewer television stations (including commercial, noncommercial, and satellite stations) licensed to the station's community of license (the "transmission test") or (b) that 25 percent or more of the area within the satellite station's Grade B contour, but outside the parent station's Grade B contour, is served by four or fewer full-power television stations (the "reception test"). The "transmission test" is satisfied here because KFCT(TV) is the only full-power television station licensed to Fort Collins. Accordingly, KFCT(TV) provides service to an underserved area.

No Alternative Operator. As the FCC previously has determined, operation of KFCT(TV) as a satellite of KDVR(TV) meets the third prong of the FCC's presumptive standard.⁶ KFCT(TV) has operated as a satellite of KDVR(TV) since the Fort Collins station began operating in 1995. As confirmed most recently in the 2008 Foxco Decision, the record continues to demonstrate "the unfeasibility of finding a purchaser willing to operate the station on a standalone basis."⁷

Of note, major broadcast television networks, including ABC, CBS, NBC, FOX, MyNetworkTV, and CW already have full-power affiliations in the market. So too do Spanish-language networks such as Univision, UniMás, and Telemundo. Thus, it is unlikely that KFCT(TV) would be able to secure a network affiliation. Viability as an independent station lacking a network affiliation is unlikely because KFCT(TV) does not provide service to the Denver metropolitan area, which has a population of over 2.5 million.⁸ The Fort Collins metropolitan area has a population of approximately 300,000,⁹ an insufficient economic base to support independent, full-service operations. For all those reasons, during the sale process that culminated in the proposed transaction, "there were no expressions of interest in KFCT as a standalone station." *See* Statement of Moelis & Company, July 12, 2013, attached hereto as Attachment A.

Conclusion. KFCT(TV) satisfies all three elements that the Commission has stated are relevant to its evaluation of requests for satellite authority. First, there was no City Grade overlap between the station and its parent station, KDVR(TV), prior to the termination of analog broadcasting. Second, KFCT(TV) serves the Fort Collins community, which is underserved. Third, there are no other buyers ready and able to purchase and operate KFCT(TV) as a full-service television station. Accordingly, reauthorization of satellite status for KFCT(TV) would serve the public interest.

2. Common Ownership of KDVR(TV) and KWGN-TV Complies With the Duopoly Rule.

Community Television Colorado is a party to an attributable Local Marketing Agreement (LMA) with Tribune subsidiary KWGN Inc. (predecessor in interest to KWGN, LLC), pursuant to which it provides services to KWGN-TV. Upon consummation of the proposed transaction, Tribune will indirectly own KWGN-TV and KDVR(TV).¹⁰ This combination in the Denver, Colorado Designated Market Area (DMA) will comply with the eight-voices/top-four-ranked stations requirements of the Duopoly Rule.

The Duopoly Rule authorizes common ownership of two television stations within the same DMA where (1) following the combination, at least eight independently-owned and operating full-power commercial and noncommercial television stations will remain in the DMA in which the communities of license of the stations subject to the transaction are located, and (2) at least one of the two commonly-owned stations is not among the top-four ranked television stations in the DMA based on audience share. Rankings are based on the most recent

all-day audience share at the time the application is filed, as measured by a professional rating service, such as Nielsen Media Research. *See* 47 C.F.R. § 73.3555(b).

As shown in Attachment C, at least eight independently-owned and operating full-power commercial and noncommercial television stations will remain in the DMA following consummation of the transaction. In addition, only KDVR(TV) is ranked among the top-4 stations in the DMA based on the most recent all-day (9 a.m.-midnight) audience share (Persons 2+), as measured by Nielsen Media Research.

3. Oaktree's Attributable Interests Would Comply With the Radio-TV Cross Ownership Rule.

The proposed acquisition of KDVR(TV) by Tribune would comply with the Radio-TV Cross Ownership Rule. Upon consummation of the proposed transaction, Oaktree will have an attributable interest in two television stations (through Oaktree's interest in Tribune) and in four radio stations (through Oaktree's interest in Townsquare) in the Denver area. Under the Radio-TV Cross Ownership Rule, a single entity may own two television stations (if permitted under the Duopoly Rule) and up to six radio stations (if permitted under Section 73.3555(a), the Local Radio Multiple Ownership Rule), provided that at least 20 independently-owned media voices would remain in the market following consummation of the proposed transaction. As shown in Attachment D, substantially more than 20 independently-owned media voices will exist in the Denver market following the consummation of the proposed acquisition of KDVR(TV) (and satellite station and KFCT(TV)) by Tribune. In addition, several cable systems provide service in the area, including Comcast and AT&T, providing an additional voice. Thus, Oaktree's attributable interests in two television stations and four radio stations in the market will comply with the Radio-TV Cross Ownership Rule.

Moelis & Company LLC ("Moelis") is a global investment bank that provides financial advisory, capital raising and asset management services to a broad client base including companies in the television and media industries. Moelis has been asked to provide its views concerning the feasibility of selling KFCT, Fort Collins, Colorado as a standalone television station.

In January 2013, Local TV Holdings, LLC ("Local TV" or the "Company") retained Moelis to advise Local TV on the sale of its television stations, including the Fort Collins satellite station, and to conduct a broad sale process. Beginning in March 2013, Moelis approached 72 buyers regarding a purchase of Local TV in whole or in part. During the sale process, which lasted several months, Moelis received no expressions of interest in KFCT as a standalone station. To our knowledge, all interested parties evaluated KFCT only as a satellite of KDVR and Moelis would not recommend that KFCT be marketed for sale as a standalone station.


