

Exhibit 1: Amendment to BPH-20050511ADR
OAHP Clearance letter
Station KFMY-FM [Facility ID 51167]

South Sound Broadcasting, L.L.C. ("South Sound"), filed an application for a construction permit to relocate the transmitter site for Station KFMY(FM), Raymond, Washington, on May 11, 2005 (BPH-20050511ADR). Therein South Sound had noted that it had made inquiry to the Washington State Office of Archeology and Historic Preservation ("OAHP") to determine what, if any, impact the construction of a new tower on its proposed site would have on any historical or cultural resources (see response in Exhibit 30 of the application).¹

Since that time, the station has retained Richard A. Daugherty, a certified archeologist, to conduct an examination of the site to determine the impact the proposed tower would have on historical and cultural properties in the area. The results of his findings were submitted to the Department of Archeology and Historic Preservation for the State of Washington and the proposed tower at the site was deemed by the OAHP to have no effect on the historic/cultural properties of the site.² Attached hereto is the letter dated June 5, 2006 from the Washington State Archeology and Historic Preservation Office agreeing with Dr. Daugherty's findings and otherwise evidencing that the South Mountain site has been cleared.³

¹This application also seeks to change KFMY's community of license from Raymond, to Oakville, Washington, and to upgrade from Channel 249 -1 to Channel 249C.

²The OAHP clearance letter refers to the site as the "Vance Creek Cell Tower" site. This identification description refers to the 7.5 minute USGS quadrangle map used by South Sound in the preparation of the engineering in support of South Sound's engineering exhibit submitted with its application. That quadrangle map includes South Mountain, the promontory on which the KFMY tower was proposed (*see* Exhibit B-3 therein).

³The OAHP letter is addressed to Mr. Gregory Smith as the manager of Puget Sound Broadcasting ("Puget"). At the time, Puget was the licensee of Station KAYO-FM (now KDDS-FM), Elma, Washington [Facility ID 33622]. Mr. Smith was the manager of both Station KFMY and KAYO-FM and was proposing that both stations would relocate their respective transmitter sites to the South Mountain location.


We would appreciate receiving any correspondence or comments from concerned tribes or other parties that you receive as you consult under the requirements of 36CFR800.4(a)(4).
