SECTION 73.207 SEPARATION STUDY

This application proposes a one-step increase in class for WAGR, Lexington, Mississippi from 273A to 273C3.

A preexisting, reserved allotment exists in Lexington, Mississippi on 273C3. Accordingly, no changes to the table of allotments are necessary. Furthermore, this application proposes facilities for WAGR at the exact same coordinates as the reference coordinates for the existing allotment.

Table 1 shows the spacing study performed for the proposed WAGR facilities. All minimum spacing requirements of 47 C.F.R. §73.207 are met with the exception of WIQQ, 272A, Leland, Mississippi and the associated allotment. This is a grandfathered short space under §73.213(c).

Note that in a recent application for construction permit filed by WIQQ (file number BPH-20070321ADG) and granted by the Commission on May 22, 2007, the existing allotment on 273C3 in Lexington, Mississippi was protected per the requirements of §73.213(c).

The minimum distance separation requirement between WIQQ on 272A and the proposed WAGR on 273C3 is 84 kilometers per §73.213(c). The actual separation between WIQQ and the proposed WAGR is 86.45 kilometers. The actual separation between the allotment on 272A in Leland, Mississippi and the proposed WAGR is 86.50 kilometers. Both cases have positive separation margin showing that all applicable requirements are met.
