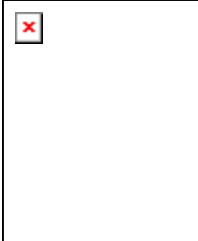

I am reviewing the extension application for WVTN-LD, Corbin, KY. The station appears to claim "financial hardship" as its justification for not completing its DTV facilities. If so, then I need a financial hardship showing for this station including: (1) an itemized estimate of the cost of meeting the build-out requirements; (2) a detailed statement explaining why its financial condition precludes such an expenditure; (3) a detailed accounting of the applicant's good faith efforts to meet the deadline, including its good faith efforts to obtain the requisite financing and an explanation why those efforts were unsuccessful; and (4) an indication when the applicant reasonably expects to complete construction. This information should be supplied as an amendment to the extension application and please "cc" me with a copy. If you have any questions concerning this matter, please contact me.
