

**A. Attributable Ownership Post-Entercom Merger**

The parties anticipate that following completion of the Entercom Merger no more than two shareholders, Joseph M. Field and possibly David J. Field, will hold 5% or more of the voting power and therefore an attributable ownership interest in Entercom. Information about Joseph M. Field and David J. Field is set forth in the table in Section B below.

CBS Corporation has, and following the completion of the Entercom Merger will continue to have, an attributable interest in the television stations identified on Appendix E to Exhibit 6 to the applications on FCC Form 315 relating to the Entercom Merger (see e.g. BTCH-20170320AHE) (the “Entercom Merger Applications”). An analysis of compliance with the radio-television cross-ownership rule is set forth in Section V.B. of Exhibit 6 to the Entercom Merger Applications, and Section VI to such Exhibit 6 contains a request for temporary waiver of the radio-television cross-ownership rule for Messrs. Moonves and Ianniello. CBS Corporation does not hold an attributable interest in any broadcast station in the Richmond, Virginia or Chattanooga, Tennessee markets.

**B. Officers and Directors of Subsidiaries of Entercom**

Following completion of the Entercom Merger, Entercom will have a number of subsidiaries, including the proposed assignee hereunder and the other entities identified on Appendix D to Exhibit 6 to the Entercom Merger Applications.
