

**EXHIBIT 13**

As of the date this application is filed, neither InterMedia Partners VII, L.P. nor its subsidiaries, InterMedia Puerto Rico Holdings, LLC, InterMedia Puerto Rico, Inc., or InterMedia San Juan, Inc., holds any Commission licenses. On November 8, 2006, however, three substantial transfer of control applications were filed by which InterMedia Partners VII, L.P. would acquire control of Televiscentro of Puerto Rico, Inc. (licensee of WAPA-TV, San Juan, Puerto Rico, WIRS(TV), Yauco, Puerto Rico, and WTIN(TV), Ponce, Puerto Rico); S&E Network, Inc. (licensee of WJPX(TV), San Juan, Puerto Rico, WKPV(TV), Ponce, Puerto Rico, and WJWN-TV, San Sebastian, Puerto Rico); and WNJX-TV, Inc. (licensee of WNJX-TV, Mayaguez, Puerto Rico).<sup>1</sup> By those transactions, S&E Network, Inc. would become a direct wholly owned subsidiary of InterMedia Puerto Rico Holdings, LLC. WNJX-TV, Inc. and Televiscentro of Puerto Rico, LLC would become indirect, wholly owned subsidiaries of InterMedia San Juan, Inc. (InterMedia San Juan, Inc. is a direct wholly owned subsidiary of

Although the Commission passed upon the qualifications of Televiscentro of Puerto Rico, LLC and WNJX-TV, Inc. to hold the licenses for WAPA-TV, WIRS(TV), WTIN(TV), and WNJX-TV when they were wholly owned subsidiaries of LIN Television Corporation, the Commission has not yet conducted this analysis for either Televiscentro of Puerto Rico, LLC or WNJX-TV, Inc. as a subsidiary of InterMedia Partners VII, L.P. The Commission will conduct this analysis, however, as part of its review of the Substantial Transfer Applications.

InterMedia Puerto Rico, Inc. InterMedia Puerto Rico, Inc. is a direct wholly owned subsidiary of InterMedia Puerto Rico Holdings, LLC. InterMedia Puerto Rico Holdings, LLC is, in turn, a direct wholly owned subsidiary of InterMedia Partners VII, L.P.) The *pro forma* transfer of control contemplated in the instant application will occur immediately following the substantial transfers of control detailed in the Substantial Transfer Applications. Thus, when the *pro forma* transfer of control occurs, the Commission will have approved the qualifications of InterMedia Partners VII, L.P. and its subsidiaries to hold controlling interests in broadcast licensees.
