

**TECHNICAL STATEMENT
LOCAL RADIO OWNERSHIP ANALYSIS
LOTUS RADIO CORP.**

Lotus Radio Corp., a Nevada corporation, is a wholly owned subsidiary of Lotus Communications Corp. (collectively the “Assignee”). This technical statement provides information in support of an application for Commission consent to the assignment of license for radio station KTHX-FM, Dayton, Nevada, Facility ID No. 48685. The Assignee currently owns and operates four AM stations and three FM stations in the Reno, Nevada, Arbitron Metro Market. Those seven radio stations are listed below:

The Assignee is presently seeking to divest its interest in AM station KFOY. It has executed an Asset Purchase Agreement with Lazer Licenses, LLC, a Delaware limited liability company (“Lazer”), and is submitting an FCC assignment application concurrently with this application.

The Assignee seeks to acquire FM station KTHX-FM in Dayton, Nevada, the subject of this application, and simultaneously divest its interest in KFOY. Upon receiving Commission approval and simultaneously closing these transactions, the

Assignee will continue to control seven commercial stations in the market – four FM stations and three AM stations. The following table lists the proposed co-owned stations:

Aside from the stations listed above, neither the Assignee, nor any of its principals have any other radio broadcast interests in the region that require an evaluation of compliance under the local radio ownership rule.

Figure 1 shows the “*FCC Geographic Market Definition for Reno, NV*” reported by BIA Kelsey. It indicates that there are thirty-six stations in the market based on the Arbitron Metro Methodology. Section 73.3555(a)(1)(ii) of the Commission’s Rules provides that in a radio market with between thirty and forty-four commercial and noncommercial radio stations, it is permissible for a party to have a cognizable interest in up to seven commercial radio stations, not more than four stations in the same service. Given the fact that the Assignee will have an interest in a total of seven commercial stations and the count of stations in the market is thirty-six, the Assignee is in compliance with Section 73.3555(a) of the Commission’s Rules concerning local radio ownership under the Arbitron Metro Methodology. However, KTHX-FM is licensed to a community that is not within the geographic boundaries of the Reno, Nevada Arbitron Metro. Accordingly, an analysis using the Interim Contour-overlap

Methodology was also conducted to determine compliance with the local radio ownership requirements.¹

Under the guidelines for applying the Interim Contour-overlap Methodology, the radio market is defined as the area encompassed by the mutually overlapping principal community contours (5 mV/m for AM, 3.16 mV/m for FM)² of the stations that are commonly attributable to the Assignee. Figure 2 depicts that the contours of the proposed co-owned stations mutually overlap and, as such, they constitute a single radio market.

From the description of the radio market above, it is apparent that the number of stations in this defined radio market is seven – four FM stations and three AM stations. Figure 2 also shows that there are a total of thirty-six radio stations, both commercial and non-commercial, which operate from transmitter locations within the defined market area. Those stations are tabulated below:



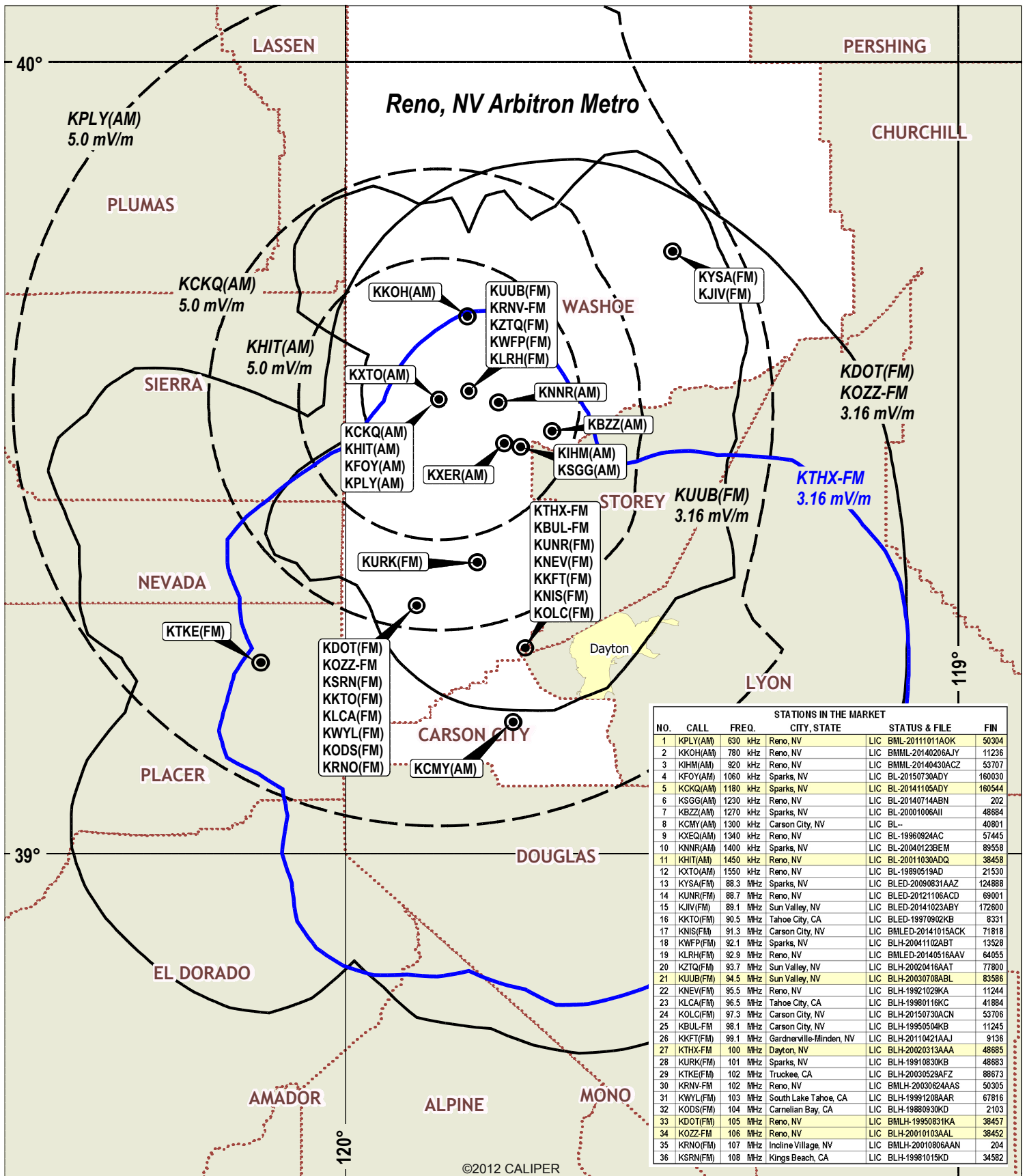
