KM LPTV of Milwaukee, LLC, KM LPTV of Chicago-28, LLC, and KM LPTV of Atlanta, LLC (hereinafter collectively "KM") submits this response to your March 13, 2012 letter (Copy Attached)(Attachment A). As a preliminary matter, the headquarters for the KM stations are in Skokie, Illinois. KM has no control over the information utilized by BHA. 5235 N. Kedzie Avenue, Chicago, Illinois is the address for WOCH-CA. That address is a strip mall which also is the address of the Kedzie Avenue Branch of Foster Bank.

The questions posed in your letter and the answers are as follows:

Note: In January 2012, the Atlanta studio was vandalized. The studio equipment and the majority of the station records (including the public inspection file) were stolen and/or destroyed. Attached to the instant submission is the police report which was filed (Attachment B) and the insurance claim which was submitted (Attachment C). The replacement studio equipment has been received and is on hand. Specifically, it is as follows:

Steps are underway to reequip the studio. It is anticipated that the aforementioned equipment and other equipment which will be acquired will enable the station to resume broadcast of local programming. The public file is being reconstructed. It is anticipated that the station will be "back to normal" by August 1, 2012.



Dear Licensee:

This is with respect to the above-referenced Class A television stations licensed to commonly-owned KM LPTV of Milwaukee, LLC, KM LPTV of Chicago-28, LLC and KM LPTV of Atlanta, LLC ("KM").

Class A television stations are accorded primary spectrum use status pursuant to the Community Broadcasters Protection Act of 1999 ("CBPA").¹ To qualify for Class A status, the CBPA provides that, during the 90 days preceding enactment of the statute, a low power television station must have: (1) broadcast a minimum of 18 hours per day; (2) broadcast an average of at least three hours per week of programming produced within the market area served by the station; and (3) been in compliance with the Commission's rules for low power television stations.² Class A licensees must continue to meet these eligibility criteria in order to retain Class A status.³

In addition, beginning on the date of its application for a Class A license and thereafter, the CBPA requires that a station must be "in compliance with the Commission's operating rules for full-power television stations."⁴ In implementing the CBPA and establishing the Class A television service, the Commission applied to Class A licensees all Part 73 regulations except for those that could not apply for technical or other reasons. Among the Part 73 requirements that apply to Class A licensees are the Commission's main studio requirements.⁵ In order to qualify as a main studio, the designated location must house production equipment and be staffed by at least two full-time personnel in order to meet the needs and interests of the residents of the station's community of license.⁶ A Class A licensee must also

maintain a local public inspection file at its main studio location which includes, *inter alia*, the station's authorization and copies of applications filed with the Commission and related materials; quarterly-based issue/programs lists; quarterly-filed FCC Form 398 (Children's Television Programming Report); letters and email from the public; and political and EEO files.⁷ In addition, a Class A licensee must place in its public file documentation sufficient to demonstrate that it is continuing to meet the on-going statutory eligibility requirement that it broadcast a minimum of 18 hours per day and an average of at least three hours per week of locally produced programming each quarter.⁸

The Licensee's chosen address of record for the three stations is the Skokie, Illinois address shown above.⁹ The staff reviewed the BIA Kelsey Inc. Media Access Pro Television Database (BIA) as of February 21, 2012, which showed that BIA lists the mailing address and "physical address" of the Milwaukee and Atlanta stations as the Skokie, Illinois address. It also identified Kevin Bae as the General Manager, Business Manager, News Director, Finance Manager, Sales Manager, Program Manager, Promotions Manager and Traffic Manager of both stations. While BIA lists 5235 N. Kedzie Avenue, Chicago, Illinois 60625 as the mailing and "physical address" for the Chicago station, that address appears to be the Kedzie Avenue Branch of Foster Bank.¹⁰

In order to determine these stations' eligibility for Class A television status, KM shall provide the following information for each station:

- 1) The street address and telephone number of each station's main studio, and the hours the designated main studio location is regularly open to the public.
- 2) A description of the production equipment maintained at the designated main studio location.
- 3) The names of the persons employed at the designated main studio location as station personnel since January 1, 2010, and their typical daily work schedule.
- 4) The street address of the location of the station's public inspection file; the hours during which the file is available for public inspection; and the name of the person with responsibility for providing access to the public inspection file.
- 5) For all four quarters of 2010 and 2011, a copy of the station's quarterly issues/programs list with a statement giving the dates on which the lists were prepared and placed in the public inspection file.
- 6) A copy of the required public inspection file documentation demonstrating that the station broadcast a minimum of 18 hours of programming per day and an average of at least three hours per week of locally produced programming for all four quarters of 2010 and 2011, with a statement giving the dates on which the documentation was prepared and placed in the public inspection file.

Your submission must be supported by the declaration of a person with personal knowledge of the facts,¹¹ and filed with the Office of the Secretary, Federal Communications Commission, 445 12th



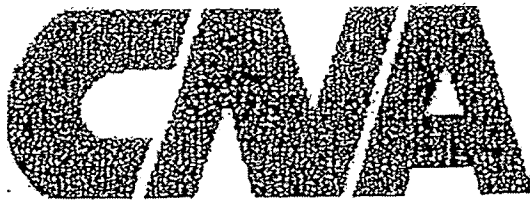

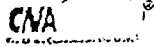
