Radio Multiple Ownership

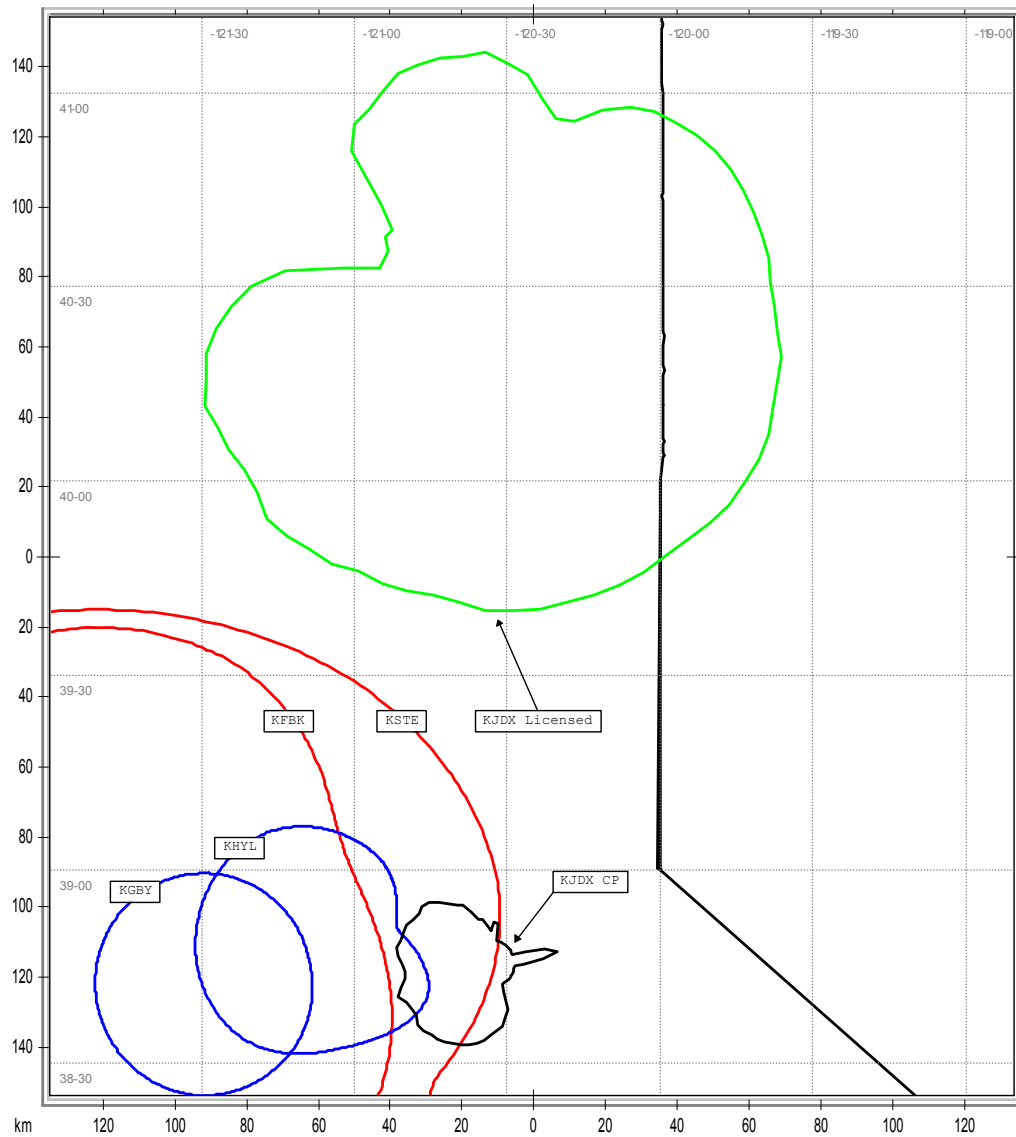
Because the principal community contour of KJDX(FM), Pollock Pines, California, intersects the principal community contour of several stations licensed to subsidiaries of Clear Channel Communications, Inc. ("Clear Channel") which are located outside any Arbitron Metro, and because KJDX is located outside any Arbitron Metro, compliance with the Commission's radio ownership limitations, 47 C.F.R. ¶ 73.3555, is demonstrated using the interim contour-overlap analysis set forth below. As shown below, the ownership combination involving KJDX complies with the radio ownership limitations. Table 1 contains a list of the Clear Channel stations included in the market. Note that the showing below considers both the currently licensed KJDX site in Susanville, CA (BLH-19860716KA) and the station's Pollock Pines construction permit site (BPH-20070226ABI).

In the market Clear Channel will have an ownership interest in 2AM and 3FM stations in a market containing 51 full power commercial and non-commercial radio stations. Thus, this combination complies with 73.3555(a) of the Commission's Rules, which provides that in a radio market with 45 or more stations one party may have a cognizable interest in up to 8 stations, of which not more than 5 are in the same service. See 47 C.F.R. ¶ 73.3555(a)(iii).
