
Dear Ms. Dortch:

Impact Radio, LLC ("Impact"), licensee of Station WLKM-FM, Facility Id. No. 70461, Three Rivers, Michigan, herein notifies the Commission that WLKM-FM, pursuant to Section 73.1620(a) (2) of the Rules, has begun operation at 50% effective radiated power with its directional facilities authorized through the grant of BPH-20080507ACJ (the "WLKM-FM Modification CP").

Impact also has filed today an application on FCC Form 302-FM for license to cover the WLKM-FM Modification CP. Through that application and through this letter, Impact also seeks Program Test Authority to commence full-power operation of WLKM-FM's new facilities.
