

**Multiple Ownership Compliance Study**  
**Greenwood, Mississippi**  
October 2006

The Multiple Ownership Compliance Study was conducted to determine if WGNL (FM) and WGNG (FM) could be co-owned by Team Broadcasting Co., Inc. and be in compliance with §73.3555 of the Commission's Rules. Greenwood, Mississippi is not located within the geographic boundaries of any Arbitron Metro; this study follows the guidelines of the Commission's Interim Contour-Overlap methodology.

The city grade contours of WGNL (FM) and WGNG (FM) comprise the subject area and form one distinct market. The city grade contour of the subject stations are shown in Exhibit 1.


The city grade contours of all FM stations providing service to the subject area are shown in Exhibit #2. The city grade contours of the AM stations providing service area are shown in Exhibit #3. The maps are followed by a tabulation of all AM and FM services to the subject area in Exhibit #4. Exhibit #4 show a total of 19 radio stations (four AM and fifteen FM stations) including the two subject stations.

FCC 301 Worksheet #2 defines the "tiers" and the limits of non-Metro local Ownership:

"In a radio market with between 15 and 29 (inclusive) commercial and noncommercial educational full-power radio stations, a party may have a cognizable interest in up to 6 commercial radio stations, not more than 4 of which are in the same service (AM or FM)."

Therefore, it is believed that the ownership of the subject stations by Team Broadcasting Co., Inc. is in compliance with §73.3555 of the Commission's Rules.

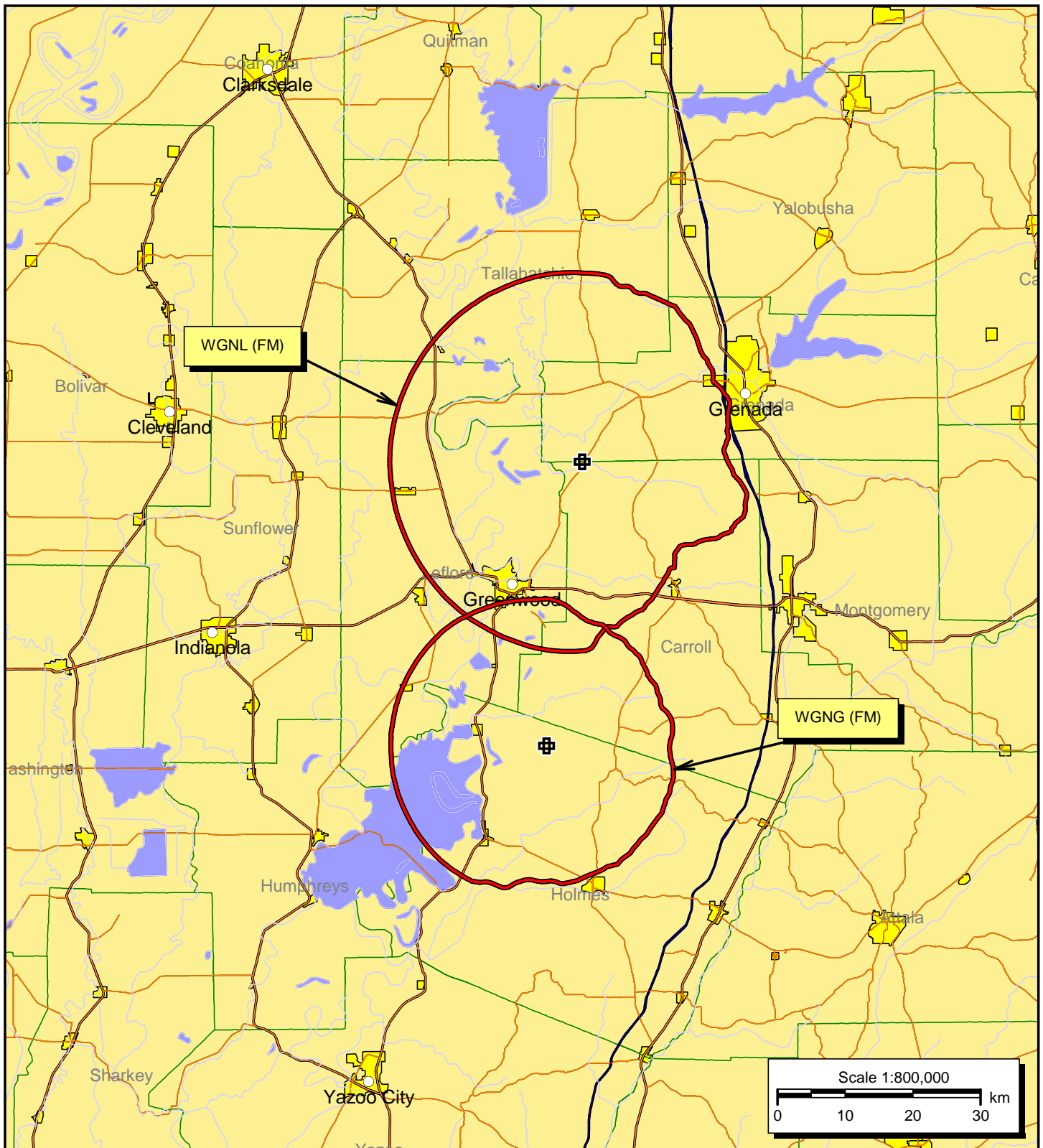

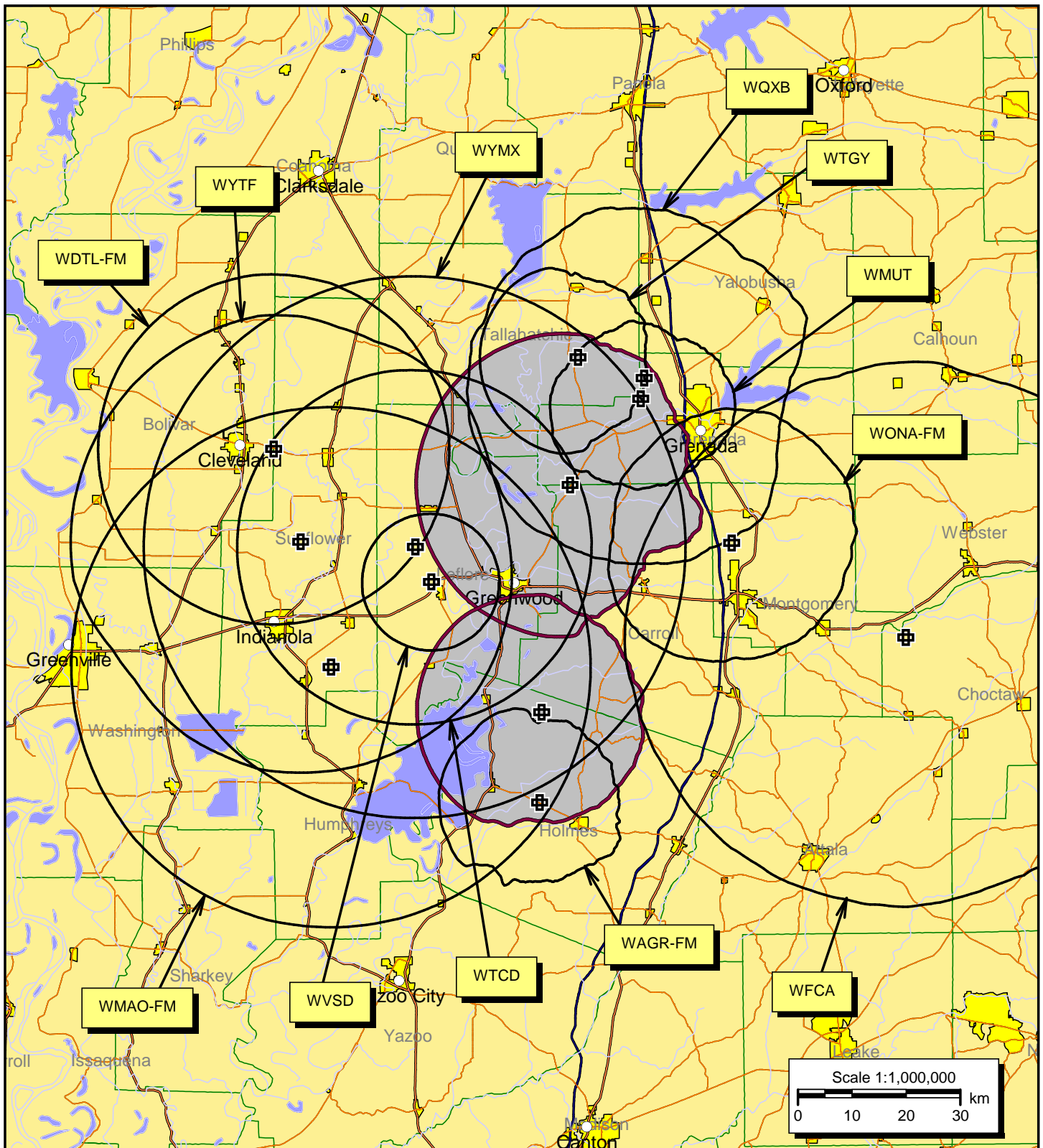

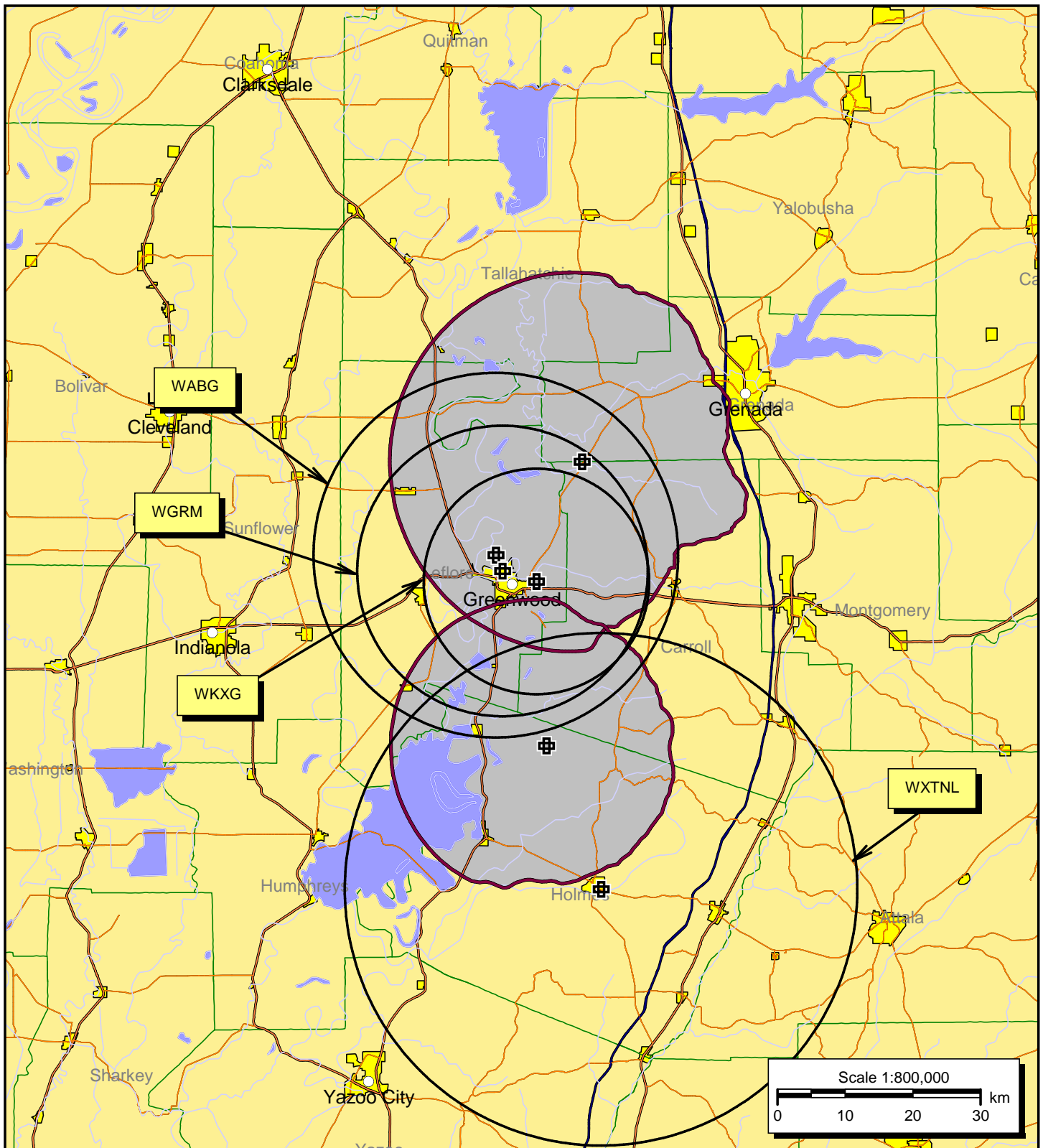
