***PRO FORMA VOLUNTARY ASSIGNMENT OF LICENSES***

1. Faith Broadcasting Network, Inc. (“Faith”) is seeking approval for a *pro forma* voluntary assignment of its WNYB, Jamestown, New York broadcast license to its affiliated ministry organization Radiant Life Ministries, Inc. (“Radiant Life”). Faith is a New York non-profit church corporation and Radiant Life is an Ohio non-profit church corporation and they share the same officers and directors:<sup>1</sup>

2. Commission Rule 73.3540(f)(5), 47 C.F.R. §73.3540(f)(5), Application for Voluntary Assignment or Transfer of Control, provides that assignment or transfer applications between organizations with the same ownership are *pro forma* and may be filed on FCC “Short Form” 316.<sup>2</sup> The rule reads:

§73.3540(f) - The following assignment or transfer applications may be filed on FCC “Short Form” 316:

\*\*\*

(5) Assignment or transfer from a corporation to a wholly owned subsidiary thereof or vice versa, or where there is an assignment from a corporation to a corporation owned or controlled by the assignor stockholders without substantial change in their interests.<sup>3</sup>

Control of a non-profit organization with a self-perpetuating board, which is the case for Faith and Radiant Life, is determined based on the voting directors.<sup>4</sup> Faith and Radiant Life share the same officers and directors, meaning other than a change in the corporate entity and name, no ultimate change in control will occur by allowing Faith to assign its broadcast license to Radiant Life. Both organizations are recognized by the IRS as tax-exempt church organizations pursuant to section 501(c)(3) of the Internal Revenue Code, 26 U.S.C. §501(c)(3).<sup>5</sup> As such, there is no equity or “ownership” interest in either Faith or Radiant Life, and control is determined based on the organizations voting directors.

4. Faith holds the following full- power license, which it seeks to *pro forma* assign to Radiant Life:

No change to Radiant Life’s licenses is proposed.

5. For the foregoing reasons, the applicants respectfully request that the Commission approve the *pro forma* voluntary assignment of the WNYB(TV) full-power television license from Faith to Radiant Life.<sup>6</sup>
