

**Assignee Exhibit 13-A**  
**Agreements and Summary of Transaction**

Pursuant to an Asset Purchase Agreement, dated as of May 13, 2014 (the “Agreement”), by and between London Broadcasting Company, Inc. (“LBC”), certain of LBC’s subsidiaries identified as “Sellers” in the Agreement, KMOV-TV, Inc. (“KMOV”), KTVK, Inc., and Gannett Co., Inc. (“Gannett”), the parties to the Agreement have agreed to assign certain television stations indirectly owned by LBC to KMOV, an indirect subsidiary of Gannett.

The parties are contemporaneously filing a total of five FCC Form 314 applications (including the instant application) seeking Commission consent to assign these licenses to KMOV.<sup>1</sup> The applications are as follows:

Gannett does not own any broadcast stations or daily newspapers in the above-referenced markets.

The stations that are the subject of this transaction have pending applications for license renewal. In *Stockholders of CBS Inc.*, 11 FCC Rcd 3733 (1995), the FCC held that it may consider and act on an application for the acquisition of multiple broadcast stations, notwithstanding the pendency of any application for renewal of license of one or more of the stations subject to the transaction. The parties respectfully request that the FCC process the license assignment applications pursuant to the procedures established in that decision. In that regard, Gannett agrees to assume the consequences associated with succeeding to the place of the existing applicant if the renewal applications for any of the stations are pending at the time that the parties consummate the transaction.

A copy of the Agreement is provided as Exhibit 13-B. The following exhibits and schedules to the Agreement and a related side letter agreement have not been attached, because such documents contain information that is proprietary, not germane to the Commission's evaluation of the application, or already in the Commission's possession.<sup>2</sup> Copies of this material will be provided to the Commission upon request, subject to the right of the parties to ask for confidential treatment of such material.
