



RADIO MULTIPLE OWNERSHIP STUDY

WUSP(FM), 105.5 MHz, Nekoosa, WI WFHR(AM), 1320 KHz, Wisconsin Rapids, WI

This statement and attached figures have been prepared on behalf of Seehafer Broadcasting Corporation, which proposes to acquire WUSP(FM) in Nekoosa, WI.

The attached Figure 1 shows the community contours of WUSP and all the stations in the Seehafer group. The only overlap situation involving WUSP and an existing Seehafer station is between WUSP and WFHR(AM) in Wisconsin Rapids, WI.

The attached study was undertaken to demonstrate that the common ownership of WUSP and WFHR complies with the radio multiple ownership rules of §73.3555 of the FCC rules using the contour overlap criteria.

An analysis was made to determine which licensed AM and FM stations place their predicted community contours over any area within the predicted community contours of either WUSP and WFHR. The AM community contour is defined as the daytime 5.0 mV/m contour, and the FM community contour is defined as the 3.16 mV/m contour (70 dBu).


Figure 2 - Multiple Ownership Study - WUSP(FM) Nekoosa WI - Seehafer Broadcasting

Figure 2 is a map showing the community contours of WUSP and WFHR, and the community contours of all stations that are in the market as established by the contours of these two stations. These stations are listed in Figure 2.


As shown herein, there are at least 16 AM and FM stations in the market, including WUSP and WFHR. A maximum of 6 commonly-owned stations is permitted under §73.3555 in a market of 15 to 29 stations, 4 of which may be in the same service (AM or FM). Therefore, the common ownership of these two stations complies with the FCC's contour overlap criteria of the multiple ownership rules.
