Mr. Shapiro holds the power to vote an additional 12.2% of the voting interests in Weigel Broadcasting Co. in his capacity as trustee or co-trustee of trusts established for the benefit of certain members of his family.

<sup>2</sup> Fred Bishop holds the power to vote 23.17% of the voting interests in Weigel Broadcasting Co. in his capacity as trustee or co-trustee of trusts established for the benefit of certain members of the family of Norman H. Shapiro. Because Messrs Shapiro and Bishop serve as co-trustees of certain of the trusts and collectively exercise the voting rights of those trusts the aggregate voting interests reported in the table above exceed 100%
