- The registered office may be, but need not be, the same as its principal office.

Other provisions: Chicago Independent Radio Project (CHIRP) will serve exclusively for educational purposes. CHIRP is dedicated to creating and operating a community radio station which broadcasts programs, including informational, cultural, and music shows, that will reach out to community members that are not served by traditional broadcast outlets. CHIRP will fulfill its educational mission in a manner similar to other community radio stations throughout the country, with programming that will reach out to a diverse audience, informing and educating by providing a forum for alternative viewpoints relevant to the community.
