**AGREEMENTS**

This application, and eleven other contemporaneously-filed applications, seek Federal Communications Commission (“FCC”) consent to the transfer of control (“Transfer of Control”) of certain broadcast license subsidiaries (“ABC Licensees”) from The Walt Disney Company (“TWDC”) to the existing shareholders of TWDC and the existing shareholders of Citadel Broadcasting Corporation pursuant to a merger.

An execution copy of the Agreement and Plan of Merger (“Merger Agreement”), by and among TWDC, ABC Chicago FM Radio, Inc., Citadel Broadcasting Corporation and Alphabet Acquisition Corp. (collectively, the “Merger Parties”), dated as of February 6, 2006, is attached to this application and will be placed in each station’s public inspection file. Also attached is a copy of the Form of Radio Disney Sales Representation Agreement (referenced in Exhibit K of the Merger Agreement).<sup>1</sup> The exhibits and schedules to these agreements have been omitted. The Merger Parties also have omitted the Separation Agreement between TWDC and ABC Chicago, which primarily addresses certain matters related to the internal reorganization of the ABC Licensees. Generally, these materials were omitted because they contain information that is proprietary, is not germane to the Commission’s evaluation of the application, and/or already is in the possession of the FCC. See LUJ, Inc., 17 FCC Rcd 16980, 16983 (2002).

The chart below describes each omission in further detail. Copies of these omitted materials will be provided to the FCC upon request, provided that the Merger Parties reserve the right, in appropriate circumstances, to submit such information pursuant to regulations restricting public access to confidential and propriety information.
