

Agreement of Assignment
Station KRBS 107.1 lpfm

This Agreement of Assignment is entered into by and between Bird Street Media Project and OROVILLE SOUTHSIDE COMMUNITY IMPROVEMENT ASSOCIATION INC, herein referred to collectively as the Parties. The Parties have entered into this Agreement as of the date accompanying the last signature subscribed below. The Parties intend themselves to be bound hereby, consideration of the mutual promises and covenants set forth here, and each Party acknowledges the actual and sufficiency of such consideration.

1. Recital. Bird Street Media Project has in effect a license from the Federal Communications Commission ("FCC") to operate KRBS 107.1 lpfm ("the station"), at or near 2360 Oro-Quincy Hwy, Oroville, CA 95966. The station is fully constructed, licensed, and on the air.
2. Agreement. Assignor agrees to assign and Assignee agrees to accept the assignment and its license. The Parties understand and agree that this Station Assignment is subject to prior FCC approval, and the Parties within five business days shall file with FCC seeking such approval and shall diligently and cooperatively prosecute such application. The parties shall divide equally any FCC filing fees that may be required, and shall separately bear their respective costs of FCC legal or engineering representation, if any.
3. Inventory. The parties shall meet and discuss any issues as to what is, or is not included in this Agreement, covering such topics as (a) equipment; (b) contracts for programming, or other services; (c) leases, (d) intangibles, trade names and miscellaneous. At the conclusion of this meeting and prior to executing this agreement, the parties shall reduce their understanding of all these matters to an Attachment A, listing all included items and, if necessary, Attachment B, listing items that need to be specifically excluded.
4. Closing. The station assignment shall be consummated at a date to be specified by no less than 10 nor more than 40 days after FCC approval of Assignment to Assignee is given.

representation, if any.


3. Assignment. The Parties shall meet and discuss any issues as to what is

their understanding of all these matters to an Attachment A listing all
included items and, if necessary, Attachment B, listing items that need to
be specifically excluded.

4. Assignment. The station assignment shall be consummated in a date to be
specified by no less than 90 nor more than 90 days after FCC approval of
Assignment to Assignee is given.

5. Formalities. The Parties enter into this Agreement of Assignment intending themselves to be bound hereby. This Agreement of Assignment shall be construed and governed under the laws of the State of California. It may be executed in counterparts. Notice for purposes of this Agreement shall be in writing, certified mail, return receipt requested or by overnight courier with confirmation of delivery. A Party giving any notice also shall forward a copy of the noticed action to the other Party by FAX, which shall not constitute notice. If it becomes necessary for a Party to obtain enforcement or interpretation of this Agreement from a court, then the prevailing Party shall be entitled to its reasonable attorneys' fees, in addition to any other relief it receives.


