¹ On June 27, 2006, KB Prime Media LLC (“KB Prime”) filed an application (“KB Application”) seeking FCC consent to assign the license of commercial television station WTLF-DT (“WTLF”) from KB Prime to Mystic Television of Tallahassee LLC (“Mystic”). See FCC File No. BALCT-20060627AAN. The KB Application remains pending before the FCC. Simultaneously herewith, Mystic is filing an application seeking FCC consent to assign the WTLF license from Mystic to MPS Media of Tallahassee, LLC (“MPS Application”). Accordingly, the MPS Application is contingent upon prior FCC approval of the KB Application and consummation of the transaction described therein.

Following FCC approval of the KB Application and consummation of the transaction described therein, Daniel J. Duman, in his capacity as controlling party of Mystic Television Broadcast Group Inc., will be the ultimate controlling party of Mystic until such time as the FCC has approved the MPS Application and the parties have consummated the transaction described therein.
