Description: WKDN PHILADELPHIA, PA – ENVIRONMENTAL PROTECTION ACT EXHIBIT

THE OPERATION OF WKDN AS PROPOSED UNDER THIS STA REQUEST WILL NOT HAVE A SIGNIFICANT ENVIRONMENTAL IMPACT AND COMPLIES WITH THE MAXIMUM PERMISSIBLE RADIO FREQUENCY ELECTROMAGNETIC EXPOSURE LIMITS FOR CONTROLLED AND UNCONTROLLED ENVIRONMENTS. THE LICENSEE OF WKDN ALSO CERTIFIES THAT IT, IN COORDINATION WITH OTHER USERS OF THE RELEVANT SITE, WILL REDUCE POWER OR CEASE OPERATION AS NECESSARY TO PROTECT PERSONS HAVING ACCESS TO THE SITE, TOWER OR ANTENNA FROM RADIOFREQUENCY ELECTROMAGNETIC EXPOSURE IN EXCESS OF FCC GUIDELINES.

Description: WKDN PHILADELPHIA, PA – SPECIAL CIRCUMSTANCES STA EXTENSION EXHIBIT

WKDN (FIN:25095), LICENSED TO FAMILY STATIONS, INC. (FSI) TO SERVE THE PHILADELPHIA COMMUNITY, EXPERIENCED POWER MODULE FAILURE ADVERSELY AFFECTING THE STATION AS A RESULT OF DAMAGE FROM A LIGHTNING STRIKE IMPACTING ITS AIR CONDITIONING UNITS AND HAS BEEN OPERATING AT ABOUT 14% DAY POWER OF THAT AUTHORIZED (OR 6,000 WATTS) SINCE 8/23/2022. ITS LICENSEE, FAMILY STATIONS, INC. (FSI), GAVE THE COMMISSION NOTICE OF ITS LOW POWER STATUS IN A LETTER DATED 9/2/2022 AND REQUESTED AN ENGINEERING STA ON 9/22/2022, WHICH WAS GRANTED BY THE COMMISSION ON 9/26/2022 (BSTA-20220922AAE).

SINCE THE LAST STA GRANT, THE LICENSEE'S ORDER OF NEW HVAC UNITS HAVE BEEN DELAYED AND ARE NOW ANTICIPATED TO ARRIVE IN APRIL 2023. AFTER INSTALLATION OF SUCH UNITS, RESUMPTION OF ITS LICENSED FACILITIES' OPERATION IS ANTICIPATED. IN THE INTERIM, THE LICENSEE RESPECTFULLY REQUESTS COMMISSION GRANT OF AN EXTENSION OF ITS CURRENT ENGINEERING STA TO OPERATE WKDN AT REDUCED POWER TO CONTINUE TO SERVE THE PUBLIC INTEREST OF PHILADELPHIA WITH MINIMAL IMPACT.
