Dear Mr. McGlynn:

This is in reference to the request filed on December 21, 2017. GMC requests an extension of the STA granted on May 12, 2017, to continue operating with parameters at variance pending completion of repairs to resolve monitoring point problems causing excessive radiation towards WAUB(AM).¹ In support of the request, GMC states that additional time will be needed to complete all work and resume licensed operations.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

We note that the previous STA expired on November 10, 2017, therefore the authority granted herein will not cover the period between the expiration date and the filing of the instant request, and is without prejudice as to whatever action the Commission may take with respect to

operation during that time period.

Accordingly, the request for extension of the STA IS HEREBY GRANTED, and GMC may continue to operate with parameters at variance from license values and/or reduced power while maintaining monitor points within license limits. GMC must reduce power further or cease operation if complaints of interference are received, and use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commissions exposure guidelines. *See* 47 CFR §1.1310. GMC will need to file an FCC Form 302 application if any significant changes to the operating parameters are needed, or submit an e-mail to my attention to certify the date the station resumed licensed operations per BL-19801113AA with negligible changes.

This authority expires on **June 22, 2018**.
