KFRQ and KFRQ.C are 2nd adjacent to the proposed translator. The weaker, and thus more fragile, of the two is KFRQ at 95.50 dBu at the proposed facility. The associated

interfering contour is 40 dB greater, or 135.5 dBu. The 50 W ERP goes only 8.3 meters from the antenna, which means it does not reach the ground 30 meters below. An aerial photo is attached to show that this is not a building mounted facility.
