Ms. Rowbotham, who is the daughter of Arthur J. and Bonnie H. Rowbotham and the granddaughter of Robert M. Hall, holds directly, as an individual, 1.20% of the equity of the company.

In addition, Benjamin Hall Rowbotham, Robert M. Hall, Jr. and Mary Hall each hold directly as individuals less than 5% of the voting stock and less than 5% of the equity of the company. Benjamin Rowbotham is the son of Arthur and Bonnie Rowbotham and the grandson of Robert M. Hall, founder of the company. Robert M. Hall, Jr. is the son of Robert M. Hall. Robert Hall, Jr. and Mary Hall are husband and wife.

Hall also owns all of the stock of Nutmeg Broadcasting Company, licensee of Stations WILI(AM) and WILI-FM, Willimantic, Connecticut (respective Facility Identification Numbers 66180 and 66179). Hall assumed control over the operation of the Willimantic stations on August 31, 2005.
