

## EXHIBIT 10

Southern Vermont College (“SVC”), licensee of Stations WBTN(AM), Bennington, Vermont, is a non-stock, non-profit educational institution. SVC is filing this application to obtain Commission consent to new members of its Board of Trustees.

The selection of SVC’s new Board of Trustees took place pursuant to its Articles of Incorporation and By-Laws. The resulting transfer of control occurred gradually, over time, through routine changes in board membership.

This application is intended to bring the station into compliance with the requirement to obtain FCC approval of the board after 50% of the members of the board of trustees have changed. The FCC last approved the board of SVC in FCC File No. BAL-20030728AFR, which was granted on August 20, 2003. The Board Members during each of the years from 2003, as of the beginning of the academic term, are set forth in the chart below.

No consideration or thing of value is being given in exchange for the interests being transferred. All Board Members are U.S. citizens. Each Board Member has one vote. None has any interests in any mass media other than WBTN.
