

## **EXHIBIT 15**

### **Radio-TV Cross Ownership**

Sorensen Television Systems, Inc., proposed assignee of Television Station KTGM(TV), Tamuning, Guam submits the following showing in compliance with Section 73.3555(c)(2)(ii) which provides that “if at least ten independently owned media voices would remain in the market post-merger an entity can directly or indirectly own, operate, or control up to two commercial TV and four commercial radio stations (to the extent permitted by Paragraph (a) of this section, the local radio multiple ownership rule).

As background, the U.S. territory of Guam is an island of approximately 200 square miles with a 2000 U.S. Census population of 150,805 and households that total 38,769. Rex Sorensen, the majority shareholder of the proposed assignee, is the majority shareholder of Sorensen Pacific Broadcasting, Inc., licensee of Radio Stations KGUM(AM) and KZGZ(FM), Agana, Guam and KGUM-FM, Dededo, Guam.

Subsection (c)(1)(i) provides that the rule is triggered when the predicted or measured 1 mVm contour of an existing FM station encompasses the entire community of license of an proposed commonly owned TV broadcast station. Attached hereto is the contour map for KZGZ(FM) included in BPH-19900530IB (which was licensed in BLH-19920925KD) which reflects that the station’s 1 mVm contour encompasses the entire island of Guam, including the entire community of license of KTGM(TV), Tamuning, Guam.

Subsection (c)(3) provides that to determine how many media voices would remain in the market after the merger one must count independently owned and operated full power broadcast TV stations within the DMA of the TV station’s community of license that have grade B signal contour overlap with the grade B signal contour of the TV station at issue. Guam is not listed by

Nielson Media Research as being a Designated Market Area or “DMA”<sup>1</sup> nor is Guam an Arbitron market. However, the Commission has determined that Guam is to be treated as one single market. See Broadcast Ownership Rules, 18 FCC Rcd 3620 (2003) at Fn. 399. Following the merger, there will be two (2) independently owned and operated full-power broadcast TV stations in the Guam market; (1) KUAM-TV, Agana, licensed to Pacific Telestations, Inc. (also the licensee of KUAM(AM/-FM); and (2) KGTF-TV, Agana, licensed to Guam Educational Telecommunications, Corp.<sup>2</sup>

Further, Subsection (c)(3)(ii) provides that independently owned operating primary broadcast radio stations that are in the radio metro market of the TV station’s community of license must be counted. Following the merger there would be eight (8) independently owned operating primary broadcast radio stations in the Guam market including (1) MOY Communications, Inc., licensee of Radio Station KOKU(FM), Hagatna; (2) Inter-Island Communications, Inc., licensee of Radio Station KISH(FM), Agana; (3) Sorensen Pacific Broadcasting, Inc., licensee of Radio Stations KGUM(AM)/-FM and KZGZ(FM); (4) Catholic Educational Radio, licensee of Radio Station KOLG(FM), Agana; (5) Good News Broadcasting Corporation, licensee of Radio Station KSDA-FM, Agat; (6) Guam Educational Radio Foundation, licensee of KPRG(FM), Agana; (7) Harvest Christian Academy, licensee of Radio Station KHMG, Barrigada; and (8) KM Broadcasting of Guam, LLC, licensee of KTKB(FM), Agana<sup>3</sup>

Subsection (c)(3)(ii) allows English language newspapers to be counted that are published at least four days a week within the TV station's DMA and that have a circulation exceeding 5 percent of the households in the DMA. At least two daily newspapers are published in Guam: "Pacific Daily News," owned by Gannett, and "Marianas Variety," owned by Younis Art Studio, Inc. (See Attached.) According to a telephone conversation between Rex W. Sorensen and the publisher of Pacific Daily News, the paper is published daily and has a circulation of 28,000 daily and 26,000 on Sunday. Similarly, according to the circulation manager of Marianas Variety, the paper is published Monday to Friday and has a circulation of approximately 5,000 daily. According to the 2000 U.S. Census, there are 38,769 total households in Guam. Therefore, each newspaper qualifies to be counted.<sup>4</sup>

Finally, Subsection (c)(3)(iv) provides that if cable television is generally available to households in the DMA, the cable system counts as one voice in the DMA. Marianas Cablevision (formerly Guam Cable TV) is a cable television and internet service provider in the Mariana Islands serving Guam which has 29,485 basic subscribers subscribing according to 2004 Television Cable Factbook. (See Attached.) Since there are less than 39,000 households in Guam, it would be reasonable to assume that the cable system is "generally available to households in the market".

Consequently, following the acquisition of KTGM(TV) there will be at least 13 independently owned media voices in the Guam market (See Attached List) and, therefore, the





# Guam probes lobbyist

## Former U.S. Attorney demoted after initial inquiry

WASHINGTON — A U.S. grand jury in Guam opened an investigation of controversial lobbyist Jack Abramoff more than two years ago, but President Bush removed the supervising federal prosecutor, and the probe ended soon after. The previously undis-

closed Guam inquiry is separate from a federal grand jury in the District of Columbia that is investigating allegations that Abramoff bilked Indian tribes out of millions of dollars. In Guam, investigators were looking into Abramoff's secret arrangement with Superior Court officials to lobby against a court reform bill


then pending in Congress. The legislation, since approved, gave the Guam

Supreme Court authority over the Superior Court. In 2002, Abramoff was retained by the Superior Court in what was an unusual arrangement for a public agency. The Los Angeles Times reported in May that Abramoff was paid with a series of \$9,000 checks funneled through a Laguna Beach, Calif., lawyer to dis-

guise the lobbyist's role working for the Guam court. No separate contract was authorized for Abramoff's work. Guam court officials have never explained the contractual arrangement. At the time, Abramoff was a well-known lobbying figure in the Pacific

# Congressional delegation arrives today

AN official congressional delegation led by the chairman of the House Small Business Committee will be stopping over on Guam today to meet with the governor, military officials and members of the business community.

Cong. Don Manzullo (R-IL), chair of the Small Business Committee, and his vice chairman, Cong. Adam Schiff (D-CA), along with other members of the delegation, will be accompanied by Congresswoman Madeleine Z.

Bordallo.

The delegation is expected to arrive at 3 p.m. today with Gov. Felix P. Camacho giving the welcoming remarks at the airport.

She said the designation of the whole Guam as a HUBZone will provide small businesses on the island with access to federal contracting dollars that can be used for commercial growth and economic development.



