


Third: Purpose for which corporation is formed

To work together to provide educational and cultural media outlets to stimulate, educate and entertain the Toledo community, in order to provide more diverse channels for individuals, groups, issues and music that have been overlooked, suppressed or under-represented by other media, in part by operating an independent, noncommercial community low power FM radio station in Toledo, Ohio, and to carry on such other activities as may be conducted by an Ohio non-profit corporation that is intended to qualify for tax-exempt status under Section 501(c)(3) Internal Revenue Code.
