**OTHER AUTHORIZATIONS; ELIGIBILITY FOR NONCOMMERCIAL
LICENSE**

The proposed assignee, Educational Broadcasting Corporation (“EBC”), is the licensee of noncommercial educational television station WNET (Facility ID No.18795), Newark, New Jersey (*see* FCC File No. BRET-19990129KN). As such, and as shown below, it is eligible to acquire the license for noncommercial educational television station WLIW (Facility ID No. 38336).

EBC, a nonprofit educational organization, hereby certifies that its current officers and governing board members are and will remain broadly representative of the educational, cultural, and civic segments of the principal community to be served by WLIW, which forms a part of the tri-state New York-New Jersey-Connecticut area. In addition, the agreement for the acquisition of WLIW provides for the addition of representatives of the current WLIW Board to the governing board of EBC.

EBC further certifies that it will use station WLIW to advance an educational program similar to that which the Commission has found qualifying in previous EBC applications relating to station WNET (including BRET-19990129KN); that its governing documents permit it to advance an educational program; and that there is no provision in any of those documents that would restrict EBC from advancing an educational program or complying with any Commission rule or policy or any provision of the Communications Act of 1934, as amended.

The following parties to the application have reported the indicated attributable interests in other broadcast stations:

1. **Jeffrey L. Bewkes**, a trustee of EBC, is Chairman of the Entertainment & Networks Group of AOL Time Warner, which has an attributable interest in the licensee of television station WTBS, Atlanta, Georgia (Facility ID No. 64033).

2. **Raymond G. Chambers**, a trustee of EBC, is also a trustee of the University of Notre Dame, which owns Michiana Telecasting Corp., licensee of WNDU-TV, South Bend, Indiana (Facility ID No. 41674), and Voice of the Fighting Irish, Inc., licensee of WSND-FM, Notre Dame, Indiana (Facility ID No. 70459).

3. **Barry Diller**, a trustee of EBC, serves as a director of The Washington Post Company, which owns (through subsidiaries) the following commercial television broadcast stations:

USA Interactive, of which Mr. Diller is Chairman and CEO and has voting control, has indirect non-controlling interests in certain low power television stations.

4. **Thomas S. Johnson**, a trustee of EBC, is also a trustee of Trinity College, the licensee of noncommercial educational station WRTC-FM, Hartford, Connecticut (Facility ID No. 68255).

5. **Thomas W. Jones**, an EBC Trustee, is a director of Fox Entertainment Group, Inc., which together with K. Rupert Murdoch owns and controls Fox Television Holdings, Inc. ("FTH"). Subsidiaries of FTH hold the licenses for the following 37 full power commercial television broadcast stations:
