

**AUCTION AUTHORIZATION**

This application is being submitted to obtain a construction permit for which Venture Technologies Group, LLC ("VTG") was the winning bidder in an auction. Pursuant to 47 C.F.R. § 73.5005(a), VTG attaches this exhibit, which provides the information required by 47 C.F.R. §§ 1.2107(d), 1.2110(j), 1.2112(a), and 1.2112(b).

Section 1.2107(d) does not apply to this application because VTG did not enter into and was not involved in any bidding consortia, joint venture, partnership or other agreement or arrangement relating to the competitive bidding process prior to the time bidding was completed. In addition, sections 1.2110(j) and 1.2112(b) do not apply to this application because VTG did not claim designated entity status in this auction.

Lawrence H. Rogow is a Manager of VTG and holds a 47% membership interest in VTG, except in the case of KBCB(TV), Bellingham, WA (Facility Id. No. 53586) ("KBCB(TV)"), with respect to which Mr. Rogow holds a 45.6311% interest.<sup>1</sup> Garry A. Spire is a Manager of

VTG and holds a 47% membership interest in VTG, except in the case of KBCB(TV), with respect to which Mr. Spire holds a 45.6311% interest.

The applicant, VTG, holds a greater than 10% interest in the entities listed below, each of which is directly or indirectly an FCC licensee or an applicant for FCC licenses and each of which is a company principally engaged in the business of broadcasting.

- 50% membership interest in Four Seasons Broadcasting, LLC, which is the sole member and Manager of Four Seasons Peoria, LLC and Four Seasons Las Vegas, LLC.
- 68.67% membership interest in World Television of Washington, LLC.
- 46.1% voting membership interest in, and Manager of, Spartan-TV, LLC.
