

**PARTIES TO THE APPLICATION**

LC Media, LP ("LC Media"), a Delaware limited partnership, is the proposed assignee of KDES-FM, Palm Springs, California.

The general partner of LC Media is LC Media, LLC (1% ownership/100% voting). The limited partners are: Roy Laughlin (9% ownership), Warren Chang (6% ownership), Warren Investments, LLC (24% ownership) ("Warren Investments"), Rosetree Partners (30% ownership) ("Rosetree"), and Gold Coast Broadcasting, LLC (30% ownership) ("Gold Coast").

LC Media, LLC has the following 4 members: Roy Laughlin (10%), Warren Chang (6%), Warren Investments (24%), Rosetree (30%) and Gold Coast (30%).

Warren Investments has the following members: Warren Chang (35% ownership/50% voting), Haesun Koo (35% ownership/50% voting), Trust FBO Niki Chang (15% ownership - sole beneficiary Niki Chang) and Trust FBO Dina Chang (15% ownership - sole beneficiary Dina Chang). Warren Investments, its members, and the trust beneficiaries do not own any broadcast interests.

The general partner of Rosetree is Saul Rosenzweig (2% ownership/100% voting). The limited partners are: Davy Rosenzweig (49% ownership) and Laurance Rosenzweig (49% ownership). Neither Rosetree nor its members own any broadcast interests.

Gold Coast has the following three members: Point Broadcasting Company (96%) ("PBC"); Jeri Lyn Broadcasting, Inc. (2%); and August G, Inc. (2%).

John Q. Hearne Revocable Trust ("Hearne Trust") holds a 90% interest in PBC and the remaining interest is held by three shareholders each with a 3.33% interest. John Hearne is the sole beneficiary and Trustee of the Hearne Trust.
