Description: REASON FOR REQUEST

ON 12/19/2008 WTPG WESTON,OH WAS GRANTED AUTHORITY BY THE FCC TO OPERATE ON CHANNEL 205/88.9MHZ. THIS CAUSED PROHIBITED CONTOUR OVERLAP FROM W205BP'S 40 DBU F(50,10)INTERFERING CONTOUR TO THE PROTECTED 60 DBU F(50,50) CONTOUR OF WTPG (EXHIBIT C). SINCE WE HAVE DETERMINED THAT A TECHNICAL RESOLUTION OF THIS INTERFERENCE MATTER CANNOT BE RESOLVED AT THE CURRENT TRANSMITTING SITE FOR W205BP, AND ALSO DUE TO THE FINANCIAL BURDEN OF HIGH TOWER RENT AT THE PRESENT LICENSED SITE OF W205BP, THE LEASE HAS BEEN TERMINATED AND W205BP WAS DECONSTRUCTED ON 3/4/2010.

CALVARY CHAPEL OF TWIN FALLS, INC.(CCTF) HAS OBTAINED PERMISSION TO CONSTRUCT W205BP TEMPORARILY ON A NEW SITE AND PLANS TO SUBMIT A MODIFICATION OF THE UNDERLYING CONSTRUCTION PERMIT FOR W205BP. CCTF REQUESTS SPECIAL TEMPORARY AUTHORITY FOR W205BP TO REMAIN SILENT UNTIL SUCH A TIME THAT A MODIFICATION IS GRANTED AND THE STATION IS RECONSTRUCTED.
