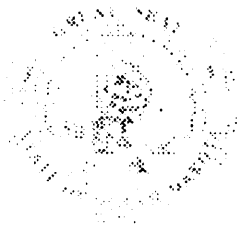

ARTICLE 5


