*Re translator to be replaced: - As filed the original Monroe, Utah application (BNPED-20071019AAT) indicated proposed divestiture of K211CL, Beaver, Utah, in response to Section IV Question 2(B). As a result of a subsequent technical amendment to Monroe to remove mutual exclusivity, and acceptance of the amended application for filing, the proposed full-service principal community contour for Monroe does not overlap that of K211CL. As diversity of ownership comparative points are not relevant to a singleton application such as Monroe has become, applicant's pledge to divest K211CL in the context of point system factors is irrelevant to the Monroe application as amended and accepted for filing.
